ORDER

REJECTION/CANCELLATION OF CANDIDATURE IN R/O TGT(MATHS) FEMALE UNDER POST CODE 37/21.

In supersession of this office previous letter No. F.No.DE.3 (31)/DRC/E-III/TGT(MATH)/FEMALE/2022/23463-67 dated 21/03/2023, candidature of following candidates have been Rejected/cancelled in r/o TGT (Maths) Female, Post Code-37/21 whereas they have provisionally Nominated & declared selected by DSSSB, Govt. of NCT of Delhi vide DSSSB vacancy advertisement no. 02/21) by the Selection Mechanism Authority i.e. DSSSB vide Result No.1475 dated 29/07/2022.

Whereas Final Notice for Joining issued to 19 candidates who have appointed to the post of TGT (Maths) Female after approval of competent authority, the candidates to whom final notice for joining has been issued are not reported/ claimed to join to respective allotted schools.

Whereas, the following candidates were nominated for the post of TGT (Maths) Female under the post code 37/21 (as per vacancy advertisement no. 02/21) by the Selection Mechanism Authority i.e. DSSSB vide Result No.1475 dated 29/07/2022 and their respective e-dossiers received from DSSSB for further proceedings of appointment. After completion of further course of documents verification on the scheduled date & time given in the Offer of Appointment letter and Medical Examination thereafter, the said candidates were provisionally appointed on purely temporary basis and appointment letter were issued to them thereof (Details mentioned in the list below).

And whereas, as per appointment order, the candidates were required to join their place of posting by the given dates therein, but they did not joined their place of duties. Hence, in continuation of appointment letters, final opportunity letters and final reminder were issued to the below mentioned candidates through by registered post and also put in the public domain of DOE MIS portal in Public Circulars section with the direction to join their duty within stipulated time mentioned in the appointment letters. The stipulated joining time has already expired despite of given ample opportunity.

Whereas, neither aforesaid appointed candidates has reported to join their duties physically nor any written request/representation for extension of joining time within the stipulated time period was submitted by the candidates to this office i.e. DoE, GNCTD in this regard. Henceforth, it is concluded that the above said candidates have not reported till now as it seems that they are not interested and claimed to join their duties to the Post of TGT (Maths) Female, Post Code-37/21, in Dte. of Education.

Whereas, in accordance with the direction mentioned in the DoPT Office Memorandum No. 35016/2/93/Estt.(D) dated 09/08/1995 referred para 2, wherein "**An Offer of appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If, however, within the specified period, a request is received from the candidate for extension of time.**"

Keeping in view of the above facts & circumstances, the appointment letters issued to the aforesaid appointed candidates are hereby required to withdrawn and the candidature of the above said 19 (Nineteen) candidates' stands cancelled henceforth, accordingly with the retrospective date of Offer of Appointment. So, it is therefore, the concerned E-dossiers file are being returned to DSSSB for further necessary action at their end with following reasons:-

"No claim for appointment, if so, made at any later stage on the basis of any ground by any candidate will be entertained by the department, in future."
