ORDER

CANCELLATION OF CANDIDATURE FOR THE POST OF TGT (SANSKRIT) FEMALE, POST CODE -55/21

Whereas, Ms. VISHU (DOB: 20/03/1990), having Roll No. 312055100023 (Dossier No. 250) was nominated by the DSSSB for the post TGT (SANSKRIT FEMALE) and she was called vide this Office memorandum no. : F.NO.DE3(42)/DRC/E-III/TGT/SANSKRIT/FEMALE/2022/7734 dated 11/11/2022, vide which the offer of appointments was issued to Ms VISHU (DOB: 20/03/1990), having Roll No. 312055100023 to submit her acceptance against the Offer of Appointment letter.

And as per the RRs, "The candidate should have studied the subject concerned as mentioned in the RRs for atleast two years during the graduation course. The elective work may also include main subject as practiced in different Universities." Scrutiny of dossier of Ms./Mrs. VISHU received from DSSSB revealed that Mrs. VISHU has studied Sanskrit subject as additional subject.

In view of the above facts and circumstances, the appointment to the post of TGT Sanskrit (Female), under post code- 55/21 in Level 7 Pay Matrix(Pre-revised Pay Band- 9300-34800 with Grade Pay of Rs. 4600/-) plus usual allowances as admissible under the deemed fit rules, is withdrawn. Now, her Candidature stands cancelled, accordingly. Candidate's E-dossier file is being sent to DSSSB for further necessary action at their end.
