ORDER
Cancellation of Candidature to the post of PGT (Physics) Male
Post Code 30/20

Whereas, **SH. SUKHJEET SINGH**, (D.O.B. 22.03.1988) (Roll No. 121203000132) has been nominated by the DSSSB for the post of PGT (Physics) Male against Post Code 30/20 vide letter No . F.4(300)/P&P/DSSSB/2019/802 dated: 07/06/2022 vide as per **Corrigendum Result Notice No.129 dated 26.05.2022.**

And Whereas, **SH. SUKHJEET SINGH** did not report in person on the scheduled date and time as given in the offer of appointment issued to him vide letter of even no. dated **18.08.2022**, Reminder dated **05.01.2023** and Final Reminder of even no. dated **20.01.2023** and neither has intimated any reason to the Directorate for not reporting and has not accepted the offer of appointment.

As per DoPT Office Memorandum NO. 35016/2/93-Estt.(D) dated 09/08/95 wherein para 2, the following has been mentioned:

"An Offer of Appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond three months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only up to a maximum period of six months from the date of issue of the original offer of an appointment. **An offer of appointment would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment.**

Therefore, In view of the facts and circumstances as above and since the candidate has wilfully chosen not to respond to the Memorandums dated **18.08.2022**, Reminder dated **05.01.2023** and Final Reminder of even no. dated **20.01.2023**, the candidature in respect of **SH. SUKHJEET SINGH** is hereby cancelled and the dossier returned to the DSSSB.
