Ref:- Directorate of Education, GNCT Delhi sent requisition for 824 post of TGT Natural Science (Female) vide this office letter no. F. No.DE.3(130)E-III/DR/Notification/2018/2182 dated 26.06.2020 and in doing so, DSSSB had published the same vacancy vide letter no. F.1(604)/P&P/DSSSB/2021/Advt./5162 dated 27.05.2021, post code 36/21 of Advertisement No. 02/2021 and declared the result of 789 successful qualified candidates vide result notice No. 130 dated 26.04.2022.

1. DSSSB forwarded the nomination letter of the successful candidates vide letter no.F.4(328)/P&P/DSSSB/2019/630 dated 13.05.2022 alongwith the waiting list contains **118** candidates **(including all category except ST)** and forwarded the e-dossier of these candidates for further process of appointment.
2. In this connection, it is informed that this office has been issued **candidature cancellation order of 33(UR-11, OBC-6, SC-11, ST-3, EWS-1, UR PH(VH)-1)** nominated candidates on the grounds that candidates have not responded/join/ not reporting other reasons. Further, 01 post of UR candidate remained vacant due to shifting of Category of M/s Monika who was earlier nominated under UR category vide- 12444-47 dated 13.02.2023. and 09 (**UR-04, OBC-0, SC-01, ST-2, EWS-2**) have resigned from the post. To fill up the said vacant posts the following candidates (UR-13, OBC-9, SC-12, ST- Not available, EWS-2) are taken up without any bias from the waiting list which was provided by the DSSSB, adhering to standard protocol in this regard.

3. The Candidates having roll nos 320036100075,412036100850 and 0313036100206 who were earlier selected in OBC Category in this post code have now been shifted in UR Category as per their merit
4. The last candidate from OBC and EWS category are on hold on account of pending ligation in the matter of Ms. Namrata Vs. DSSSB (O.A. No. OA No.1345/2022) and O.A. No. 1356/2022 & 1360/2022 (for EWS Case.)
5. The selection of the above 36 candidates (UR-16, OBC-09, SC-12, ST Not suitable candidate available in waiting panel PH(OH VH)-01) Not suitable candidate available in waiting panel, EWS-02 shall be further subject to verification of the candidature of the candidate by this Department including the identity of the candidate
6. The Selection of the above 36 candidates (UR-16, OBC-09, SC-12, ST Not suitable candidate available in waiting panel PH(OH VH)-01) Not suitable candidate available in waiting panel, EWS-02 shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRS and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs. signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by DoE, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of

the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, age and other essential certificates.

7. DoE (Education Department) shall also check the eligibility of the reservation benefit, if any. Further, if applicable, and shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. Further, the DoE, being appointing authority shall verify and satisfy authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate.
8. The DoE, being appointing authority shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93- Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
9. The DoE, being appointing authority shall also get the SC/ST/OBC certificates verified from the issuing authority before his/her appointment. Further, in case of OBC Candidates it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt of India, DOPT O. M. No. 36012/22/93- Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/10/2008 and OM No. 36033/1/2013-Estt. (Res) dated 27/05/2013 & 13.05.2017.
10. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
11. The DoE, being appointing authority shall verify that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
12. **The above result is subjected to the outcome of the court cases, if any, pending in various courts related to this post.**
13. **While every care has been taken in preparing the result, the Directorate of Education reserves the right to rectify errors and omissions, if any detected at any stage.**
14. **Mere inclusion of the name of candidate from the waiting list does not confer any right upon the candidature over the post unless the competent authority is satisfied after such enquiry/verification that the candidate is suitable in all respect for appointment to the post.**
