
CANCELLATION OF CANDIDATURE FOR THE POST OF TGT (NATURAL SCIENCE) POST CODE-36/21

Whereas, Ms. Shalini (DOB: 11-02-1991), having Roll No. 312036100538 (Dossier No. 463) was nominated by the DSSSB for the post TGT (Natural Science) and she was called vide this Office memorandum no. : **F.NO.DE3(30)/DRC/E-III/TGT/NATURAL SCIENCE/ FEMALE/ 2022/30394** dated 11/04/2023 (Reminder –IV Final) , vide which the offer of appointments was issued to Ms. Shalini (DOB: 11-02-1991), having Roll No. 312036100538 to submit her acceptance against the Offer of Appointment letter but the said candidate did not reported at the given scheduled date & time of DV. Soon after, the candidate was submitted her written consent vide letter dated 11/04/2023 that "**she is unable to come in this office for Document verification and has requested to cancel her candidature**".

And whereas, In view of the above facts and circumstances, the act on the part of the aforesaid candidate is taken as refusal to accept the OoA and it is concluded that the candidate is not interested in the appointment to the post of TGT Natural Science (Female).

Now whereas, the Offer of Appointment issued Mr./Ms./Mrs. Shalini (DOB: 11-02-1991), Roll No. 312036100538 is hereby withdrawn and her Candidature stands cancelled , accordingly. 
