Cancellation of Offer of Appointment to the post of PGT (Sanskrit) Male

Whereas, **Sh. AMIT KUMAR**, D.O.B. **15/01/1994**, Roll No. **111307600105** has been nominated by the DSSSB for the post of PGT (Sanskrit) Male against Post Code 76/20 vide letter no. F.4(292)/ DSSSB/P&P/2019/6124 dated 10.10.2021 vide Result Notice No. 55 dated 16.11.2021 and accordingly an Offer of Appointment was issued to him vide this Directorate Memorandum No. 352 dated 20/02/2023, the second opportunity was given to him vide reminder-I Memorandum No. 549 dated 13/03/2023 and Final Opportunity vide Memorandum 673 dated 29/03/2023.

2. And Whereas, **Sh. If however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond three months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only up to a maximum period of six months from the date of issue of the original offer of an appointment". **An offer of appointment would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment.**
