ORDER

CANCELLATION OF CANDIDATURE FOR THE POST OF TGT SOCIAL SCIENCE Male POST CODE 39/21

Whereas, Sh. Vinit Dabas (DOB 02.07.1991), Roll No. 112303900032 under OBC category has been nominated provisionally by the DSSSB to the post of TGT Social Science (Male) under post code 39/21 vide result notice No. 132 dated 28.04.2021.

And whereas, Sh. Vinit Dabas has filled the online application form in DSSSB for the post of TGT social science, male post code 39/21 under DSSSB advertisement No. 02/21, with mentioning Bachelor of Arts from EILMU University, Pass year 02/2013, Percentage 69.41 in submitted online application form.

And whereas, as per the e-dossier verification report candidate has uploaded only the marksheets & certificate of Graduation from EILM University vide Enrolment No. *EILMU/09/F26397* and DSSSB has provisionally selected this candidature on the basis of submitted document after scrutinised and same has been forwarded by the DSSSB in e-dossier for further process of appointment.

And whereas, the candidate has also submitted the another BA degree vide enrolment no. 13SRU1141ARA9205 and marksheet at the time of document verification which was never forwarded by DSSSB, & thus this qualification has not scrutinized & candidate has selected provisionally only on Graduation from EILM by board not another BA degree.

And whereas, in the earlier case UGC, Ministry of Education Government of India informed through a detailed letter wherein it was mentioned, among other things, that "Director (Higher Education), Human Resource Development Department, government of Sikkim may validate the degrees of 2009-2010 in three disciplines i.e. B.A. (Hospitality & Tourism), BCA and MBA for students admitted within the territorial jurisdiction of State of Sikkim based on the admission records available with the university's Sikkim campus/State Government. Degrees in other disciplines except in three as specified in preceding lines and beyond academic year 2009-2010 shall not be valid.


And whereas, Joint Director, Higher Education, Education Deptt., Govt. of Sikkim informed that "*Bachelor of Arts (General) is not a UGC recognized course for EILM University, Sikkim. As such the attached documents of Vinit Dabas bearing enrolment no EILMU/09/F26397 is not valid/genuine*".

And whereas, the matter of Sh. Vinit Dabas was placed before Competent Authority Dte. of Education, GNCTD for final decision and it has been decided & approved that the reject/cancel the candidature for the post of TGT (Social Science)-Male, Post Code 39/21 on account of Degree/Certificate of Graduation done from EILM University, Sikkim during January, 2009 to June, 2012 vide Enrollment no. *EILMU/09/F26397* being not Valid/Genuine.

Therefore, the candidature of Sh. Vinit Dabas (DOB 02.07.1991), Roll No. 112303900032 under OBC category is hereby rejected/cancelled for the post TGT Social Science (Male), Post code 39/21 with the prior approval of the Competent Authority and his dossier is returned to DSSSB.

Therefore, Keeping in view of the above facts & circumstances, the offer of appointment issued to Sh. Vinit Dabas, Roll. No. 112303900032 under OBC category is hereby withdrawn and the candidature for the post of TGT Social Science Male Post Code 39/21 is hereby stand cancelled/rejected with the prior approval of the Competent Authority, accordingly with the retrospective date of OoA and E-dossier is being returned to DSSSB for further necessary action at their end.

ORDER

CANCELLATION OF CANDIDATURE FOR THE POST OF TGT SOCIAL SCIENCE Male POST CODE 39/21

Whereas, the following candidates were nominated for the post of TGT (Social Science) under the post code 39/21 (as per vacancy advertisement no. 02/21) by the Selection Mechanism Authority i.e DSSSB vide Result No. 132 dated 28/04/2022 and their e-dossiers received from DSSSB for further proceedings of appointment. During the course of documents verification on the scheduled date & time given in the Offer of Appointment letter, it was noticed that the candidates possessed B.Ed Degree from Singhania University, Rajasthan which was not recognized by National Council Teacher Education.

And whereas, deficiency notices were issued to the candidates vide which they were asked to clarify such deficiency. In response to the deficiency memo, no clarification and no such requisite documents i.e NCTE Certificate was not submitted by the candidates and Singhania University recognition order issued by NCTE.

And whereas, a letter for taking action/to seeking clarification from NCTE has been sent to Regional Director, West Wing, Dwarka, NCTE vide letter no. 4544-45 dated 16/01/2023 to clear the air in the matter as the matter intertwined in terms of possessed qualification of candidates. In response to the query, Regional Director, has informed this office and it is revealed that "Singhania University, Village Pacheri Bari, Jhunjhunu, Rajasthan -333515, was never recognized by NRC, NCTE for conducting B.Ed Course" vide letter no. F.No.NCTE-Regl011/10/2023-Regulation Section (RJ)-WRC/222993 Dated 19th April 2023.

Now whereas, in accordance with the direction mentioned in the Offer of Appointment Memorandum of DOE referred para 9 (e), wherein "The candidate has to produce NCTE (National Council for Teacher Education) recognition certificate of the institute/College/University by which the candidate completed his/her B.Ed degree course/B.El.Ed/B.P.Ed Degree course/D.Ed (applicable for TGTs, PET/Asst. Teacher(Primary), Asst. Teacher (Nursery) as the case may be"

Keeping in view of the above facts & circumstances, the appointment letters issued to them are hereby withdrawn and the candidature of the above said 03 (Three) candidates stand cancelled accordingly with the retrospective date of OoA, if any issued to them. The concerned E-dossier file is being returned to DSSSB for further necessary action at their end.

"No claim for appointment, if so, made at any later stage on the basis of any ground by any candidate will be entertained by the department, if future."
