ORDER

Cancellation of Offer of Appointment to the post of PGT (English) Female
Post Code 26/20

Whereas, **Ms. ANURADHA HALDER**, D.O.B. 06.02.1995, Roll No. 11280800242 has been nominated by the DSSSB for the post of PGT (English) Female against Post Code 26/20 vide letter no.F.4(298)/ P&P/DSSSB/2019/734 dated 31.05.2022 vide Result Notice No. 852 dated 10.05.2022. Vide Offer of Appointment No.F.DE.2(80)/DRC(E-II)/PGT(English)/Female/2022/2556 dated 04.11.2022, the candidate was called for document verification and during the course of verification of documents, it was found that the candidate has completed her M.A.(English) degree for the session 2017-19 from IGNOU & B.Ed. degree for the session 2017-19 from The University of Burdwan i.e. completed both degrees in the same session. Consequently, vide letter no. No.F.DE.2(80)/DRC(E-II)/PGT(English)/Female/2022/2750 dated 09.11.2022 a deficiency memo in this regard was issued to the candidate. The candidate replied in response to the aforesaid deficiency memorandum.

And, whereas, Distance Education Council, IGNOU vide his letter no. F.No.DEC/Notification/40.5.1.5/2012/15983-16229 dated 01.11.2012 under subject "Policy on pursuing two or more programmes simultaneously in various combinations" has stated that: "A student can pursue two programmes simultaneously through distance or combination of distance and regular modes from the same or different University/Institution(s) in various combinations, viz..

1. One Degree and one Diploma/ Post Graduate Diploma/ Certificate
2. One Post Graduate Diploma and one Diploma/Certificate
3. One Diploma and one Certificate
4. Two Post Graduate Diplomas
5. Two Diplomas
6. Two Certificates."

Therefore, in view of the facts and circumstances as above and since the candidate has acquired two essential qualification degrees at the same time which is not covered under the above said notification dated 01.11.2012 issued by IGNOU, the candidature in respect of **Ms. ANURADHA HALDER** for the post of PGT (English) is hereby **cancelled** and her dossier returned to the DSSSB.


