ORDER  
CANCELLATION/REJECTION OF CANDIDATURE FOR THE POST OF TGT English Male.  
(MALE) POST CODE-131/17

Whereas, Sh. Pardeep Kumar, Roll No. 2650008100 under OBC category was selected for the post of TGT English (Male) under the post code 131/17 (as per vacancy advertisement no. 04/17) by DSSSB vide Final Result Notice No. 562 dated 11/12/2019, nominated and forwarded his e-dossier for further proceedings of appointment.

And whereas, Offer of Appointment letters issued to candidate for further due course of documents verification on the scheduled date & time given in the Offer of Appointment letter vide this Directorate memorandum dated 15.09.2022 and subsequently reminders dated 23.12.2022, 10.01.2023 and 07.02.2023.

And whereas it is clearly mentioned in their offer of appointment that 'in case he/she does not appear in person or no reply received in this office within one month from the date of issue of this offer letter, cancellation proceedings would be initiated without any further reference to the candidate'.

And whereas, Sh. Pardeep Kumar didn't reported/appeared on the scheduled date & time given in the Offer of Appointment letter along with the required/requisite relevant documents before the assigned scrutiny team.

And whereas, Sh. Pardeep Kumar was found absent/not reported for Document Verification in spite of giving ample opportunities.

Keeping in view of the above facts & circumstances, the offer of appointment issued to Sh. Pardeep Kumar Roll. No. 2650008100 under OBC is hereby withdrawn and the candidature for the post of TGT English (Male) under the post code 131/17 is hereby stand cancelled/rejected, accordingly with the retrospective date of OoA and E-dossier is being returned to DSSSB for further necessary action at their end.
