CANCELLATION ORDER

**Cancellation of Appointment and Candidature to the post of PGT Home Science (Female)
Post Code 81/20**

Whereas **Ms. Priyanka Verma (DOB- 07/07/1993), (Roll No. 121208100354)** has been nominated by the DSSSB for the post of PGT Home Science (Female) against Post Code 81/20 vide letter No.F.4(291)/P&P/DSSSB/2019/866 dated 22/06/2022 and Result Notice No. 1392 dated 15/06/2022 and accordingly after the successful verification of documents, she was Appointment by Directorate Recruitment Cell E-II vide appointment order No. DE.2(83)/DRC(E-II)/PGT/Home Sc.)/Female/2022/1944 dated 30/08/2022 and was required to join her respective place of posting by 30/09/2022.

Further, the candidate requested for extension for joining her place of posting, consequently, vide Notice for Joining (Reminder-1) of even no. 2567 dated 09/11/22, the candidate was directed to join her place of posting by 07/10/2022 and vide Final Notice for Joining of even no. 736 dated 13.4.23, she was directed to join her place of posting by 21/04/2023.


And whereas, **Ms. Priyanka Verma (Employee ID - 20222843)** did not join/report her respective place of posting i.e., Yamuna Vihar, Block C, No.1- SKV (School ID: 1104018) in the prescribed time as mentioned in Notice for Joining (Reminder-1) of even no. 2567 dated 09/11/22 and Final Notice for Joining of even no. 736 dated 13.4.23. She has neither joined her respective place of posting nor intimated any reason to Directorate Recruitment Cell E-II for not joining her duty in the respective place of posting on said scheduled date and time.

As per DoPT Office Memorandum NO. 35016/2/93-Estt. (D) dated 09/08/95 wherein para 2, the following has been mentioned:

"An Offer of Appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If, however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond three months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and, in any case, only up to a maximum period of six months from the date of issue of the original offer of an appointment". **An offer of appointment would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment.**

Therefore, in view of the above facts and circumstances the appointment and candidature in respect of **Ms. Priyanka Verma (Employee ID - 20222843)** for the **post of PGT Home Science (Female) & Post Code-81/20** is hereby **cancelled**, and her dossier returned to the DSSSB.
