ORDER

Cancellation of Offer of Appointment to the post of PGT (Commerce) Male
Post Code 23/20

Whereas, **Shri DEEPAK SINGHAL**, D.O.B. 27.05.1992, Roll No. 11250400018 has been nominated in waiting panel list by the DSSSB for the post of PGT (Commerce) Male against Post Code 23/20 vide letter no.F.4(304)/DSSSB/P&P/2019/299 dated 18.02.2022 vide Result Notice No. 824 dated 12.01.2022 and accordingly an Offer of Appointment for verification of documents was issued to him vide this Directorate Memorandum No.F.DE-2(66)/DRC(E-II)/PGT(Commerce)/Male/2021/343 dated 16.02.2023, the second opportunity was given to him vide reminder-I Memorandum No.F.DE-2(66)/DRC(E-II)/PGT(Commerce)/Male/2021/565 dated 14.03.2023 and Final Opportunity vide Memorandum No.F.DE-2(66)/DRC(E-II)/PGT(Commerce)/Male/2021/624 dated 21.03.2023.

And Whereas, **Shri DEEPAK SINGHAL** did not report in person on the scheduled date and time as given in the offer of appointment issued to him vide letter of even no. dated 16.02.2023, Reminder-I of even no. dated 14.03.2023 and Final Reminder of even no. dated 21.03.2023. He has neither accepted the offer of appointment nor has intimated any reason to this Directorate for not accepting the offer of appointment and not reporting on said scheduled date and time.

1. As per DoPT Office Memorandum NO. 35016/2/93-Estt.(D) dated 09/08/95 wherein para 2, the following has been mentioned:

"An Offer of Appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond three months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only up to a maximum period of six months from the date of issue of the original offer of an appointment". **An offer of appointment would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment.**

Therefore, in view of the facts and circumstances as above and since the candidate has willfully chosen not to respond to the memorandums dated 16.02.2023, 14.03.2023, and 21.03.2023, the candidature in respect of **Shri DEEPAK SINGHAL, Roll No. 11250400018** is hereby **cancelled** and his dossier returned to the DSSSB.

ORDER

Cancellation of Appointment to the post of PGT (Commerce) Male Post Code 23/20

Whereas, **Shri DIXIT YADAV**, D.O.B. 07.06.1995, Roll No. 11140400018 has been appointed vide appointment order no. F.DE-2(66)/DRC(E-II)/PGT(COMMERCE)/MALE/2021/2834 dated: 05.12.2022 to the post of PGT (Commerce) and was required to join his respective place of posting by 04.01.2023. Since, the candidate did not joined the place of posting within stipulated time, therefore, vide notice of joining reminder-I no. F.DE-2(66)/DRC(E-II)/PGT(COMMERCE)/MALE/2021/622 dated: 21.03.2023 & Notice of Joining (Final Reminder) no. F.DE-2(66)/DRC(E-II)/PGT(COMMERCE)/MALE/2021/717 dated: 10.04.2023, he was asked to join the place of posting within stipulated time, but the candidate did not join.

And Whereas, **Shri DIXIT YADAV** did not report in person on the scheduled date and time as given in the said appointment order, notice of joining reminder-I & Notice of Joining (Final Reminder) issued to him. He has neither joined nor has intimated any reason to this Directorate for not joining the requisite place of posting on said scheduled date and time.
