And whereas, as per the e-dossier verification report candidate has uploaded only the marksheets & certificate of Graduation from EILM University vide Enrolment No. **EILMU/09/F26397** and DSSSB has provisionally selected this candidature on the basis of submitted document after scrutinised and same has been forwarded by the DSSSB in e-dossier for further process of appointment.

And whereas, the candidate has also submitted the another BA degree vide enrolment no. 13SRU1141ARA9205 and marksheet at the time of document verification which was never forwarded by DSSSB, & thus this qualification has not scrutinized & candidate has selected provisionally only on Graduation from EILM by board not another BA degree .
