**ORDER**

**CANCELLATION OF CANDIDATURE FOR THE POST OF TGT (NATURAL SCIENCE) POST CODE-36/21**

**Whereas**, Ms. Nidhi Kumari (DOB: 14-03-1994), having Roll No. 339036100122 candidates under ST Category were nominated for the post of TGT (Natural Science) under the post code 36/21 (as per vacancy advertisement no. 02/21) by the Selection Mechanism Authority i.e. DSSSB vide Result No.130 dated 26/04/2022 and her e-dossiers received from DSSSB for further proceedings of appointment. For the appointment purpose, Offer of Appointment letter issued to the said candidate for further due course of documents verification on the scheduled date & time given in the Offer of Appointment letter.

**And whereas**, during the process of document verification by the assigned team, the verification team found that the aforesaid candidate does not have proper valid reservation as per the notified Recruitment Rules as per the vacancy advertisement for the said post. The Scrutiny DV team issued Deficiency Memo to the candidate the above deficiency and in response to the memo, the candidate submitted the reply but was not satisfactory. In the meanwhile, the department sought clarification from the concerned reservation certificate issuance authority. The Revenue Officer, District Champaran, Bihar submitted the following response thereof:

*"General Administrative Department, Govt. of Bihar wherein the government endorsed the order of Hon'ble Supreme Court judgment dated 21/02/2022 in the matter of Sunil Kumar Rai &Ors. Vs. The State of Bihar &Ors. In Writ Petition (Civil) No. 1052 of 2021(Placed at page no. 87/C-113/C) vide which clearly mentioned that 'Lohara' is a member of the Scheduled Tribes, 'Lohar' is not."*

*"As per the order of Hon'ble Supreme Court 'Lohar' doesn't belong to ST Community implemented by Bihar Government w.e.f. 19/04/2022."*

*The legal advisor, Legal Branch, Directorate of Education, GNCTD also given the nod to make the necessary candidature rejection on the basis of Hon'ble Supreme Court Judgment dated 21/02/2022*

In view of the above circumstance and facts, the department has come to the conclusion that Ms. Nidhi Kumari (DOB: 14-03-1994), the candidate do not have any valid reservation certificate for taking benefit as per the set RRs for the post of TGT, Natural Science as the candidate not fulfil the required ***following essential Reservation Clause mentioned*** in the notified vacancy advertisement for the said post :

**6. RESERVATION BENEFITS:**


***(i) Reservation benefits will be available to the EWS/SC/ST/OBC/PwD& other special category candidates in accordance with the instructions / orders / circulars issued from time to time by the Govt. of NCT of Delhi.***

***(ii) Candidates who wish to be considered against reserved vacancies and /or to seek age relaxation, must be in possession of relevant certificates (EWS/SC/ST/OBC/Non Creamy layer/PwD/Educational/Experience etc.) issued by the competent/notified authority (in prescribed format) on or before the cutoff date (closing date of advertisement) otherwise their claim for any category will not be entertained and their applications will be considered against Un-reserved (UR) category vacancies, if eligible otherwise. The candidate has to select that particular category when applying online for the Post. No request for change of Category will be entertained at any later stage.***

Keeping in view of the above facts & circumstances, the appointment letter issued to you are hereby withdrawn and your candidature stand cancelled, accordingly with the retrospective date of OoA. The concerned E-dossier file is being returned to DSSSB for further necessary action at their end.

***"No claim for appointment, if so, made at any later stage on the basis of any ground by any candidate will be entertained by the department, in future."***


