Cancellation of Candidature for the post of Domestic Science Teacher, under post code-88/20.

Whereas, Ms. Sonia, DOB-19.05.1987, Roll No. 121108800032, Selection Category-UR was nominated by DSSSB for the post of Domestic Science Teacher, under post code-88/20 in Directorate of Education, Govt. of NCT of Delhi vide result notice no. 87 dated 05/01/2022 and accordingly offer of appointment was issued to her vide No. F.DE.4 (32)/DRC/E-IV/DST(88/20)/2022/3034 dated 15/06/2022.


And, whereas, whose documents verification has been done on 04.07.2022 with the direction to submit the NCTE certificate for the concerned course and NCL Certificate valid for the financial year 2019-2020 vide letter dated 04.07.2022. Subsequently three reminders were also been issued to the candidate on dated 26.07.2022, 22.08.2022 and 21.09.2022 but no reply has been received till date.

And whereas, for verification of OBC Certificate a letter was sent to SDM, Rajouri Garden, Delhi on dated 08.09.2022 in which they informed that her OBC Certificate has been cancelled vide letter No. F.1(1)/SDM(RG)2022/14127 dated 04.10.2022.

Therefore, on the above facts and circumstances the Memorandum of Offer of Appointment No. F.DE.4 (32)/DRC/E-IV/DST(88/20)/2022/3034 dated 15/06/2022 issued to Ms. Sonia, DOB-19.05.1987, Roll No. 1121108800032, Selection Category-OBC-GCT is hereby **withdrawn and candidature stands cancelled**.


