## **ORDER**

Whereas, Ms. Komal Gahlot (Employee I.D. 20201214) TGT Assistant Teacher (Primary) under post code 15/19 was appointed purely on **Temporary and provisional basis in relaxation with FR 10 (4)** with the direction to report at their respective place of posting latest by 25.12.2020 at West Patel Nagar-SKV-1516142 vide order No. DE.4 (16)/DRC/E-IV/PRT(15/19)/2020/7495 dated 25.12.2020 Posting I.D. 20200160, failing which her appointment shall stand cancelled without any further communication.

And Whereas, Ms. Komal Gahlot has joined her respective school on 08.07.2021 and continued till 06.08.2021. Thereafter, she has not attended the school due to her medical condition.

And whereas, HOS vide letter No. SKV/WPN/2021/1395 dated 14.09.2021 has directed Ms. Komal Gahlot to join her duties w.e.f. 15.09.2021.

And whereas, HOS has also issued Show Cause Notice dated 04.12.2021 to Ms. Komal Gahlot, Assistant Teacher (Primary) directing her to join the school immediately failing which disciplinary action will be initiated against her.

And whereas, in reply to Show Cause Notice dated 04.12.2021, Ms. Komal Gahlot Assistant Teacher (Primary) has sent an email on 18.12.2021 vide which she has informed the HOS that her medical condition suddenly took a dip and she was not allowed to travel in order to gain her complete fitness, but in the meantime she recovered and appeared for her Medical Examination at DDU Hospital, Hari Nagar and she is recovering as expected but as per doctor advise she is not allowed to travel for some more time and need rest before joining her regular duties. But she failed to join her duties till date.

And Whereas, Show Cause Notice was also issued from the Office of Dy. Director of Education Distt. West-A vide letter No. DE.48/DWA/ADMN./2022/968 dated 24.08.2022 with the direction to join her duties immediately on receipt of this Show Cause Notice alon gwith Medical fitness report, failing which necessary action u/r 5.1.a of CCS (Temporary Service) Rules, 1964 will be initiated against her without further correspondence in the matter.

And Whereas, That the Chairman, Medical Board Deen Dayal Hospital has informed vide letter No. F.1 (1)/DDU/MB/2022/20378/19587 dated 06.09.2022 that the candidate will not be able to discharge her duties efficiently and continuously and hence NOT FIT for Job of a teacher in government service at present".

**And Whereas,** her matter is still under process and her probation is going to be expired very shortly i.e. on 07.07.2023.

**Now, Therefore,** the probation of Ms. Komal Gahlot (Emp. ID.-20201214) Assistant Teacher (Primary) is hereby extended for a period of 1 (One) Year i.e. from 08.07.2023 to 07.07.2024 in addition to the period of 2 years as prescribed in the Appointment Order issued to Ms. Komal Gahlot for the post of Assistant Teacher (Primary).
