**ORDER**

**Cancellation of Offer of Appointment to the post of EVGC Female**  
**Post Code 36/20**

Whereas, **Ms. PREETI**, D.O.B. 12.07.1987, Roll No. 121103600562 was nominated by DSSSB for the post of EVGC-Female against Post Code 36/20 vide letter no.F.4(273)/P&P/DSSSB /2019/652 dated 19.05.2022 vide Result Notice No. 843 dated 05.05.2022. Vide Offer of memorandum no. F.No.DE.2(76)/DRC(E-II)/PGT(EVGC)/FEMALE/2022/287 dated 15.02.2023, Ms. Preeti was called for verification of documents on 28.02.2023 and during the course of document verification it was observed that the registration number on marksheets was different than the registration number on certificate of the said Diploma. Consequently, vide deficiency memo no. F.No.DE.2(76)/DRC(E-II)/PGT(EVGC)/FEMALE/2022/3198 dated 28.02.2023, the candidate was asked to submit clarification in this regard. The candidate submitted copy of certificate of diploma with updated registration number.

And whereas, the candidate submitted certificate and marksheets of Diploma in Guidance and Counseling (DGC) from Apex Professional University, Arunachal Pradesh bearing different registration number and thereafter, submitted new certificate bearing updated registration number. Vide letter no. F.No.DE.2(76)/DRC(E-II)/PGT(EVGC)/FEMALE/2022/2708 dated 20.12.2022, the Controller of Examination/ Vice Chancellor of the University was requested to verify the marksheets and certificate of said diploma.

And whereas, the University vide letter no. REG/DOVE/22/08/02-23/032 dated 10.02.2023 has declared that:-

**"We found that such certificate is not issued by the Apex Professional University as well this candidate is not in the rolls of the University. We hereby confirm you that no such record are available in the University database."**

Therefore, in view of the facts and circumstances as above and since Apex Professional University, Arunachal Pradesh has **declared that the certificate of Diploma in Guidance and Counseling (DGC) is not issued by the University as well as Ms. Preeti is not in the rolls of the University**, the candidature in respect of **Ms. PREETI** is hereby **cancelled** and her dossier returned to the DSSSB.
