**ORDER**

**Cancellation of Offer of Appointment to the post of EVGC Female**  
**Post Code 36/20**

Whereas, **Ms. SWATI DHANKAR**, D.O.B. 21.09.1992, Roll No. 121203600382 was nominated by DSSSB for the post of EVGC-Female against Post Code 36/20 vide letter no.F.4(273)/P&P/DSSSB /2019/652 dated 19.05.2022 vide Result Notice No. 843 dated 05.05.2022. Vide Offer of memorandum no. F.No.DE.2(76)/DRC(E-II)/PGT(EVGC)/FEMALE/2022/2309 dated 26.09.2022, Ms. Swati Dhankar was called for verification of documents on 28.09.2022 and during the course of document verification some deficiencies were observed and the said candidate was directed to submit the requisite documents vide this Directorate Deficiency Memorandum No. 2541 dated 28/09/2022, the First opportunity to submit the requisite deficiency document was given to her vide reminder-I Deficiency Memorandum No. 528 dated 09/03/2023, the second opportunity to submit the requisite deficiency document was given to her vide reminder-II Deficiency Memorandum No. 693 dated 05/04/2023, and Final Opportunity vide Deficiency Memorandum No. 836 dated 04/05/2023.

2. And Whereas, **Ms. SWATI DHANKAR** did not give her representation regarding the said deficiency in this Directorate issued to her vide letter of even no. dated 28/09/2022, Reminder-I of even no. dated 09/03/2023, Reminder-II of even no. dated 05/04/2023 and Final Reminder of even no. dated 04/05/2023 has neither intimated any reason to this Directorate for not responding to the deficiency memorandum.
3. As per DoPT Office Memorandum NO. 35016/2/93-Estt.(D) dated 09/08/95 wherein as per para 2, the following has been mentioned:

"An Offer of Appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond three months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only up to a maximum period of six months from the date of issue of the original offer of an appointment". **An offer of appointment would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment.**

Therefore, In view of above, the candidature in respect of **Ms. SWATI DHANKAR**, D.O.B. **21/09/1992**, Roll No. **121203600382** is hereby cancelled and her dossier returned to the DSSSB.
