**ORDER**

**REJECTION/CANCELLATION OF CANDIDATURE IN R/O Ms. VANITA YADAV FOR THE POST OF TGT PUNJABI (FEMALE) UNDER POST CODE 57/21.**

Whereas, **Ms. Vanita Yadav D.O.B. 22.10.1990, Roll No. 111105700057** has been provisionally nominated & selected by the DSSSB under OBC category subject to fulfilling all conditions of eligibility for appointment to the post of TGT Punjabi (Female) Post Code 57/21 under OBC category in Directorate of Education, Govt. of NCT of Delhi.

And Whereas, during the preliminary scrutiny of dossier it has been found that caste OBC bearing No. OBC/2018/5532 dated 18.10.2018 issued from Haryana, while DSSSB vide para 6(iii) of Advt. No. 03/2021 states that only OBC (Delhi) candidates notified by GNCT of Delhi will be given the benefit of reservation/age relaxation under OBC category

And whereas, Ms. Vanita Yadav has not replied any memorandum dated 08.06.2022 and subsequently reminders dated 07.07.2022, 20.07.2022 & 15.12.2022 has been issued with the directing to submit the OBC (Delhi) certificate within 07 days.

And whereas, Offer of appointment dated 27.01.2023 subject to submission of deficiency memo issued & candidate appeared for document verification on 08.02.2023 but she did not replied.

And whereas, final reminder of deficiency dated 06.04.2023 with the directing to submit the reply within 07 days, failing which action as deemed fit will be taken accordingly without any more notice. Candidate has not replied to any memorandum inspite of final re *minder*.

*Therefore, in view of the above facts and circumstances, the candidature of Ms. Vanita Yadav, (DOB 20.10.1990) Roll No. 111105700057 for the post of TGT Punjabi female, Post Code 57/21 of DSSSB Advertisement vide NO. 03/21 dated 27.05.2021 under OBC category is hereby rejected/cancelled due to non submission of valid Delhi OBC certificate and her e-dossier returned to the DSSSB, GNCTD.*
