**CANCELLATION ORDER**

Whereas, vacancy of TGT (Math) (Male) under post code 38/21, were advertised by DSSSB vide advertisement no. 02/2021 vacancy notice dated 12/02/2021

And whereas, reference to above said vacancy , **Sh. Harish Yadav S/o Sh. Narshi Yadav** (DOB: 04-03-1997) R/o Village- Rai Singh Ka Bass, Post- Dhobalai, Via Govindgarh, Tehsil-Chou, District-Jaipur, State-Rajasthan, Pincode-303712 applied under OBC category.

And whereas, **Sh. Harish Yadav S/o Sh. Narshi Yadav** (DOB: 04-03-1997) Roll No. **121203802116** has been provisionally nominated by DSSSB, GNCTD for the post of TGT Math (Male) post code 38/21 under the selection category UR vide result notice no. 1473 dated 27/07/2022.

And whereas, during the preliminary scrutiny of documents of the said candidate, it has been found that **Sh. Harish Yadav** (Roll No. **121203802116** ) does not possesses the CTET qualification before the cut off date, which is required as per the advertisement of DSSSB for the said post vacancy.

And whereas, in this regard, he was given an opportunity to submit explanation vide Deficiency Memo No.DE.3(32)/DRC(E-III)/TGT(Maths)/Male/2022/173 dated 10/01/2023. And in reply the said candidate vide letter Dy. No. 274 Dt. 09/2/2023, he had stated that "he qualified CTET exam after the cut off date because CTET paper was not done due to COVID disease so his CTET is after cutoff date".

And whereas, reply given by candidate is not satisfactory and it is clear from the above facts that **Sh. Harish Yadav**, (Roll No. **121203802116**, does not possess qualification of CTET before the cut off date i.e. 04/07/2021 (extended date) as he qualified the CTET on 09/03/2022.

Now, therefore, as **Sh. Harish Yadav**, (Roll No. **121203802116**), does not fulfill the required eligibility as per the terms & conditions of the advertised vacancy by the DSSSB, GNCTD, vide vacancy notice no. 02/2021 for the post of TGT Math (Male) post code 38/21, his candidature/nomination for the post of TGT Math (Male) is hereby **cancelled/rejected** and no further communication in this regard will be entertained in future.

**CANCELLATION/REJECTION ORDER**

Whereas, vacancy of TGT (Math) (Male) under post code 38/21, were advertised by DSSSB vide advertisement no. 02/2021 vacancy notice dated 12/02/2021

And whereas, reference to above said vacancy, Sh. Pabitra Biswas S/o Sh. Ganesh Chandra Biswas (DOB: 03-05-1993) R/o Village- Kumirkola, Post-Rupsa, Police Station- Khandaghosh, District-Burdwan, State-West Bengal, Pincode-713142 applied under SC category.

And whereas Sh. Pabitra Biswas S/o Sh. Ganesh Chandra Biswas (DOB: 03-05-1993) Roll no 121103800974 has been provisionally nominated by DSSSB, GNCTD for the post of TGT Math (Male) post code 38/21 under the selection category SC vide result notice no. 1473 dated 27/07/2022.

And whereas, he was issued a memorandum dated 18/10/2022 for offer of appointment to the post of TGT Math -Male 38/21 and during the document verification of the said candidate, it has been found that Sh. Pabitra Biswas (Roll No. 121103800974), **has not studied "Hindi" at any level.**

And whereas, in this regard, a Deficiency Memo vide letter No DE.3(32)/DRC/E-III/TGT(Maths)/Male/2022/5088 dated 21/10/2022 was issued to him. And in reply the said candidate vide letter Dy. No. 94 Dt. 03/11/2022, had stated that " he has not studied Hindi in any class, but he can read write and speak hindi well and able to teach mathematic in Hindi medium, he has work experience in Hindi".

And whereas, the reply given by candidate is not satisfactory and it is clear from the above facts that Sh. Pabitra Biswas, (Roll No. 121103800974), does not possess the qualification i.e. working knowledge of hindi, as he has not studied Hindi in any class upto 8<sup>th</sup> level or in any class above 8<sup>th</sup> level.

Now, therefore, as Sh. Pabitra Biswas, (Roll No. 121103800974), does not fulfill the required eligibility as per the terms & conditions of the advertised vacancy by the DSSSB, GNCTD, vide vacancy notice no. 02/2021 for the post of TGT Math (Male) post code 38/21, his candidature/nomination/offer of appointment for the post of TGT Math (Male) is hereby **cancelled/rejected** and no further communication in this regard will be entertained in future.
