ORDER

Cancellation of candidature for the post of TGT Math (Male), Post Code -38/21

Whereas, the Candidate namely Kapil Dev, Roll No. 111103800526 (Category UR) was nominated for the post of TGT Maths (Male) under post code-38/21 (Group "B") (As per vacancy advertisement no. 02/21) by the Selection Mechanism Authority i.e. DSSSB Result noticed no. 1473 dated 27-07-2022 and his Dossier received from DSSSB for further proceedings towards consideration of appointment for aforesaid post. Accordingly, a Memorandum i.e. 'Offer of Appointment' dated 18/10/2022 was issued.

And Whereas, during the Document Verification Kapil Dev Roll No. 111103800526 was Issued a Deficiency Memo vide letter No. F.No. DE 3(32)/DRC/E-III/TGT(Math)/MALE/2022/1067 dated 20-10-2022 that regarding seeking age relaxation in the applied Sub Category i.e. GCT & hiding info. that he is serving as Junior Assistant on the cutoff date.

And whereas, in response of deficiency memo he explained that he had been working as Guest Teacher in Directorate of Education from Session 2014-15 to 2017-18 for which he is seeking age relaxation and further he was selected as Junior Assistant in Delhi Govt. in 2018 and presently working as Junior Assistant.

And whereas, he attained the age of 32 Years 05 Months 25 Days on the cut off date i.e. 24/06/2021. While as per as per vacancy advertisement no. 02/21 of DSSSB, a applicant should be below 32 years and to seek the age relaxation under sub category "GCT", a contractual employee should be working on the cutoff date to get age relaxation in upper age limit. Neither he was working as Guest/Contractual Teacher on the cut off date and nor he fulfills the criteria for age relaxation as a Departmental Candidate, because he is working as Junior Assistant i.e. Group "C" post in Delhi Govt. since 02.11.2018.

And whereas, DSSSB vacancy notice advertisement no. 02/21 vide letter No. F.1 (603)/P&P/DSSSB /2021/Advt./5110 Dated: 12/05/2021 , clearly stipulates regarding age relaxation that:-

2.	Age Relaxation for Contractual Employee	As per terms & conditions of Services Department (GNCTD)'s Office memorandum No. F. 19(11)/2015/S-IV/1751-1756 dated 11/06/2019. " The contractual employees working against teaching posts will be eligible for one time relaxation in upper age limit up to maximum

Therefore, in view of the above facts and circumstances and since the candidate does not fulfill the age relaxation criteria and is overage on the cutoff date, the Memorandum for Offer of Appointment dated 18-10-2022 issued to Kapil Dev S/o Sh. Randhir Singh, Roll No. 111103800526 (DOB: 05/01/1989) is hereby withdrawn and candidature of the aforesaid candidate stands cancelled accordingly with the retrospective date of 'Offer of Appointment'.
