Whereas, the under mentioned 09 (Nine) candidates were nominated for the post of TGT (Maths) Female, Post code 37/21 as per vacancy advertisement no. 02/21 by the Selection Mechanism Authority i.e. DSSSB vide Result No.1475 dated 29/07/2022 and their respective e-dossiers received from DSSSB for further proceedings of appointment.

And whereas, under mentioned candidates were asked to submit their requisite documents/clarifications in regard to their deficiencies have been noticed during the scrutiny of documents by the designated Document Verification Teams on the scheduled dates and time and thereafter, subsequent reminders and Final/Last reminders were issued to the below mentioned candidates through by registered post and also put in the public domain of DOE MIS portal in Public Circulars section with the direction to submit the requisite documents/clarifications within stipulated time mentioned in the subsequent reminders despite of given ample opportunity :-

And whereas, as per DSSSB vacancy advertisement No.02/21 terms & conditions for reservation benefits will be available to the EWS /SC/ST/PwD & other special category candidates in accordance with the instruction/orders/circulars issued from time to time by the Govt. of NCT of Delhi. Candidate who wish to be considered against reserved vacancies and/or to seek age relaxation, must be in possession (EWS /SC/ST/OBC/Non Creamy layer/PwD/Educational/Experience etc. issued by the competent/notified authority in prescribed format on or before the cut off date (closing date of advertisement of the post) otherwise their claim for any category will not be entertained and their applications will be considered against Un-reserved category vacancies, if eligible otherwise. The candidate has to select that particular category when applying online for the post. No request for change of Category will be entertained at any later stage.

And whereas, Directorate of Education, GNCTD has provided adequate opportunities to an aforesaid nominated candidates to submit their requisite documents/clarifications and neither they have turned up to submit any reply nor through their representatives to this directorate within stipulated time given to them, henceforth, it is concluded that aforementioned candidates have not interested for the appointment to the Post of TGT (Maths) Female, Post Code-37/21, as offered to them by the Dte. of Education, GNCTD.

Keeping in view of the above mentioned facts & circumstances, aforesaid 09 (Nine) candidates have not fulfilled the relevant RRs and terms & conditions etc as per advertisement concerned. Henceforth, candidature of aforesaid candidates as offered for Appointment stands withdrawn and cancelled and concerned E-dossiers are being returned to DSSSB for further necessary action at their end with following reasons:-
