If however within the specified period a request is received from the candidate for extension of time, it may be considered by the ministry/department but extension beyond 3 months should not be granted liberally."

Therefore, in view of the above facts & circumstances, as stated above and since the candidate has wilfully chosen to join in TGT (Hindi) Female. Therefore the candidature in r/o **RANI** is hereby cancelled and dossier is returned to DSSSB.

"No claim for appointment, if so, made at any later stage on the basis of any ground by any candidate will be entertained by the department, in future."
