CANCELLATION OF CANDIDATURE FOR THE POST OF TGT (SANSKRIT) FEMALE, POST CODE -55/21

Whereas, Ms. JYOTI (DOB: 28/11/1986), having Roll No. 112005500205 was nominated by the DSSSB for the post TGT (SANSKRIT FEMALE) and she was called vide this Office memorandum no. **F.NO.DE3(42)/DRC/E-III/TGT/SANSKRIT/FEMALE/2022/34037** dated 18/04/2023, vide which the offer of appointments was issued to Ms. JYOTI (DOB: 28/11/1986), having Roll No. 112005500205 to submit her acceptance against the Offer of Appointment letter. The said candidate reported at the given scheduled date & time of DV and a deficiency memo was issued vide No. **F.NO.DE3(42)/DRC/E-III/TGT/SANSKRIT/FEMALE/2022/1195** dated **22/05/2023**. A deficiency reminder was also issued to Ms. Jyoti dated 07/06/2023. However, no reply/representation was submitted by Ms. Jyoti to remove the deficiency memo issued.

And whereas, in view of the above facts and circumstances, it is concluded that the candidate is not interested in the appointment to the post of TGT Sanskrit (Female), under post code- 55/21 in Level 7 Pay Matrix (Pre-revised Pay Band- 9300-34800 with Grade Pay of Rs. 4600/-) plus usual allowances as admissible under the deemed fit rules.

Now whereas, the Offer of Appointment issued Ms./Mrs. JYOTI (DOB: 28/11/1986), having Roll No. 112005500205 is hereby withdrawn and her Candidature stands cancelled, accordingly. ORDER

CANCELLATION OF CANDIDATURE FOR THE POST OF TGT (SANSKRIT) FEMALE, POST CODE -55/21

**Whereas**, Ms. NITTU (DOB: 07/08/1990), having Roll No. 314055100055 was provisionally nominated by the DSSSB for the post of TGT SANSKRIT (FEMALE), Post Code – 55/21 vide result notice 167 dated 16/08/2022.

Ms. NITTU (Roll No. 314055100055) is in possession of two caste certificates of two different categories i.e. one for OBC and another for SC, issued by two different states authorities i.e. Rajasthan and Haryana & Punjab respectively.

**And whereas**, as per the circular letter No. 35/1/72-R.U. (SCT.V), dated 02/05/1975 on the subject: Issue of Schedule Castes & Schedule Tribes Certificate. Point no. 2 (Cases of Migration) of said circular is reiterated as under:

- (i) *Where a person migrates from the portion of the states in respect of which his community is scheduled to another part of the same states in respect of which his community is not scheduled, he will continue to be deemed to be a member of the schedule caste or the schedule tribe, as the case may be, in relation to that state;*
- (ii) *Where a person migrates from one state to another, he can claim to belong to a schedule caste or schedule tribe only in relation to the state to which he originally belonged and not in respect of the state to which he has migrated.*

In view of the above facts and circumstances, the appointment of Ms. NITTU (Roll No. 314055100055) to the post of TGT Sanskrit (Female), under post code- 55/21 in Level 7 Pay Matrix (Pre-revised Pay Band- 9300-34800 with Grade Pay of Rs. 4600/-) plus usual allowances as admissible under the deemed fit rules, is withdrawn. Now, her candidature stands cancelled, accordingly. Candidate's E-dossier file is being sent to DSSSB for further necessary action at their end.
