CANCELLATION ORDER

Whereas, vide advertisement no. 02/2021 vacancy notice dated 12/02/2021 DSSSB advertised the vacancy of TGT (Math) (Male) under post code 38/21.

And whereas, reference to above said vacancy , Sh. YASH PAL S/o Sh. BALDEV PRASAD (DOB: 18-04-1995) R/o VILL PATRASIA POST AND THANA BARKHERA TEH BISALPUR, DIST PILIBHIT, UTTAR PRADESH Pincode-262203 applied under OBC category.

And whereas, on coming in merit in UR category from UR-WL & on receipt of e-Dossier of Sh. YASH PAL, (Roll No. 112403800570) from DSSSB, GNCTD, preliminary scrutiny of documents were done and it has been found that Sh. YASH PAL, (Roll No. 112403800570) has uploaded the CTET result which shows that he has qualified the CTET exam securing 89 marks availing OBC category benefit. Also the candidate has uploaded caste certificate OBC (UP) issued from UP Govt.

And whereas, as per the vacancy advertised by the DSSSB only the candidate who possesses the OBC (Delhi) certificate issued from Delhi Govt. is entitle for OBC reservation/relaxation benefits.

And whereas, an opportunity was given to him to explain vide Deficiency Memo No.DE.3(32)/DRC/E-III/Edn./Maths(Male)/2023/47963 dated 06/06/2023. And in response to said Deficiency Memo , no response in written has been received from the said candidate.

And whereas, it is clear from the above facts that Sh. YASH PAL, (Roll No. 112403800570), is not eligible to be selected under UR category as he has secured only 89 marks and qualified the CTET exam availing OBC (U.P.) category benefits and also he is not eligible to be selected for post of TGT (Maths) Male 38/21 under OBC category as he does not possess caste certificate i.e. OBC (Delhi) according to e-Dossier of him.

Now, therefore, as Sh. YASH PAL, (Roll No. 112403800570), does not fulfill the required eligibility as per the terms & conditions of the advertised vacancy by the DSSSB, GNCTD, vide vacancy notice no. 02/2021 for the post of TGT Math (Male) post code 38/21, his candidature/nomination for the post of TGT Math (Male) is hereby **cancelled/rejected** and no further communication in this regard will be entertained in future.

CANCELLATION ORDER

Whereas, vide advertisement no. 02/2021 vacancy notice dated 12/02/2021 DSSSB advertised the vacancy of TGT (Math) (Male) under post code 38/21.

And whereas, reference to above said vacancy , Sh. SHUBHAM KUMAR DUBEY S/o Sh. CHANDRA PRAKASH DUBEY (DOB: 15-05-1996) R/o KAPOORPUR BARAIPAR MACHHALISHAHAR JAUNPUR UTTAR PRADESH Pincode-222144 applied under UR category.

And whereas, on coming in merit in UR category from UR-WL & on receipt of e-Dossier of Sh. SHUBHAM KUMAR DUBEY (Roll No. 121103801015) from DSSSB, GNCTD, preliminary scrutiny of documents were done and it has been found that Sh. SHUBHAM KUMAR DUBEY (Roll No. 121103801015) has uploaded the CTET result which shows that he has qualified the CTET exam on 09/03/2022, which is after cut-off date i.e. 04/07/2021 (last extended date of application submission).

And whereas, an opportunity was given to him to explain vide Deficiency Memo No.DE.3(32)/DRC/E-III/Edn./Maths(Male)/2023/47962 dated 06/06/2023. And in response to said Deficiency Memo , a representation was received from Sh. Shubham Kumar Dubey, vide letter Dy. No. 165B dated 23/06/2023, wherein he cited the reason that "due to pandemic Corona the CTET exam got delayed and due to this his exam result was also delayed and he got the CTET qualification on 09/03/2021 , that's why he got the CTET qualification after cut-off date".

And whereas, as per the vacancy notice vide Advt. No. 02/21 issued from DSSSB , the educational qualification, age, experience etc. as stipulated in advertisement shall be determined as on the closing date of submission of application. Hence, it is clear from the above facts that Sh. SHUBHAM KUMAR DUBEY, (Roll No. 121103801015), does not possess the CTET qualification on or before the closing date of submission of application i.e. 04/07/2021, . Also the reply submitted by the said candidate, is found not satisfactory.

Now, therefore, as Sh. SHUBHAM KUMAR DUBEY, (Roll No. 121103801015), does not fulfill the required eligibility as per the terms & conditions of the advertised vacancy by the DSSSB, GNCTD, vide vacancy notice no. 02/2021 for the post of TGT Math (Male) post code 38/21, his candidature/nomination for the post of TGT Math (Male), post code 38/21, is hereby cancelled/rejected and no further communication in this regard will be entertained in future.
