CANCELLATION ORDER

Whereas, Sh. YOGESH KUMAR, D.O.B. 04.12.1990, Roll No. 112103500143 has been provisionally nominated & selected by the DSSSB for appointment to the post of TGT Natural Science(Male) post code 35/21 under UR category in Directorate of Education, Govt. of NCT of Delhi and he was called vide this Office memorandum no. F. No.DE.3 (29)/DRC/E-III/TGT (Natural Science)/Male /2022/ 9619 dated 08.12.2022, vide which the offer of appointment was issued to Sh. YOGESH KUMAR and to submit his acceptance against the Offer of Appointment letter.

Whereas, in response to this, the said candidate has reported at scheduled date, time & venue of DV. However, requisite documents required for the post of TGT Natural Science (Male) were not submitted.

And whereas, during the scrutiny of dossier of candidate, it was found that the candidate has not studied the main subject i.e. Biology, Chemistry, Botany, Zoology, Physics for upto two year (4 semester) during his Graduation/B.Sc. Period i.e. 2009-11 that is required for this post as essential qualification as per Vacancy Notice Advertisement No. 02/21 dated 12.05.2021 & RRs. The Candidate studied Physics & Chemistry as additional subject in the Year 2014 & 2016 that will be counted as after completion of his Graduation.

And whereas, a deficiency memo was issued vide letter no. F. No.DE.3 (29)/DRC/E-III/TGT (Natural Science)/Male /2022/478 dated 15.12.2022. In response to this deficiency memo, two replies have been received on 28.12.2022 & 09.01.2023. However, submitted replies are not on merit and as per RRs as Graduation Degree with elective /Main subject as regular is required.

And whereas candidate has failed to submit requisite documents for essential qualification as per RR's and the matter of candidate was considered in this Directorate and rejected by the Competent Authority as the candidate has not having essential qualification as per RR's for the Post of TGT (Natural Science)- Male.

Therefore, in view of the above facts and circumstances, the candidature of Sh. YOGESH KUMAR, D.O.B. 04.12.1990, Roll No. 112103500143 under 'UR' category for the post of TGT (Natural Science)- Male, Post Code 35/21 according to DSSSB's Vacancy Notice Advertisement vide no. 02/21 under is hereby **withdrawn** and **Stands Cancelled** accordingly with the retrospective date of 'Offer of Appointment'. The concerned e-dossier is being returned to DSSSB separately for further necessary action at their end, if any.

"No claim for Appointment, if so, made at any later stage on the basis of any ground by any candidate will be entertained by the Department, in future."
