ORDER

REJECTION/ CANCELLATION OF CANDIDATURE IN R/O PARVESH KUMAR FOR THE POST OF TGT(HINDI) MALE UNDER POST CODE-34/21

Whereas, Sh. PARVESH KUMAR, D.O.B. 25.05.1986, Roll No. 113903400012 has been provisionally nominated & selected by the DSSSB for appointment to the post of TGT HINDI(Male) post code 34/21 under OBC category in Directorate of Education, Govt. of NCT of Delhi and he was called vide this Office memorandum no. F.NO. DE.3(28)/DRC/E-III/TGT/HINDI/MALE/2022/34006 dated 17.04.2023, vide which the offer of appointment was issued to Sh. PARVESH KUMAR and to submit his acceptance against the Offer of Appointment letter.

Whereas, in response to this, the said candidate has reported at scheduled date & time of DV. However, requisite documents required for the post of TGT Hindi (Male) were not submitted.

And whereas, during the scrutiny of dossier of candidate, it was found that candidate has not study Hindi as regular subject moreover marks obtained have also not been added in the grand total in B.A, whereas as per RR's the essential qualification for the post of TGT (Hindi) Male required is as under:-

B.A (Honours) in one of the Modern Indian Language (MIL) concerned or B.A with MIL concerned as one of the elective subjects from a recognized university having 45% marks in aggregate with one additional language or one school subject* at degree level.

OR

Equivalent oriental degree in MIL concerned from a recognized university having 45% marks in aggregate.

And whereas, a deficiency memo was issued vide letter no. DE.3 (28)/DRC/E-III/TGT (HINDI)/MALE/2022/51069 dated 14.06.2023. In response to this deficiency memo, the reply has been received on 28.06.2023. However, reply is not on merit and as per RR's B.A degree with elective /Main subject as regular is required.

And whereas candidate has failed to submit documents for essential qualification as per RR's and the matter of candidate was considered in this Directorate and the candidature of candidate is cancelled by the Competent Authority as the candidate has not having essential qualification as per RR's for the post of TGT (Hindi) Male as he has not study Hindi as regular subject moreover marks obtained have also not been added in the grand total in B.A.

Therefore, in view of the above facts and circumstances the candidature of Sh. PARVESH KUMAR, D.O.B. 25.05.1986, Roll No. 113903400012 for the post of TGT (Hindi) Male, post code 34/21 of DSSSB advertisement vide no. 02/21 under OBC category is hereby Rejected/ Cancelled and his e-dossier returned to the DSSSB, GNCT of Delhi.

"No claim for appointment, if so, made at any later stage on the basis of any ground by any candidate will be entertained by the department, in future."
