ARUN KUMAR, D.O.B. 06.03.1986, Roll No. 112403400046 has been provisionally nominated & selected by the DSSSB for appointment to the post of TGT HINDI(Male) post code 34/21 under UR category in Directorate of Education, Govt. of NCT of Delhi. and he was called vide this Office memorandum no.: F.NO. DE.3(28)/DRC/E-III/TGT/HINDI/MALE/2022/4768 dated 13.10.2022 vide which the offer of appointment was issued to SH. ARUN KUMAR and to submit his acceptance against the Offer of Appointment letter.

Whereas, in response to this, the said candidate has reported at scheduled date & time of DV and has accepted the offer of appointment.

Whereas, as per point 7 in the advertisement no 02/21, relaxation in upper age upto 05 years will be given for the Departmental candidates with atleast 03 years continuous service as Central Govt. Civilians employees including employees of Govt. of NCT of Delhi in Group B post, which is in the same line or allied cadres and where a relationship could be established that the service already rendered in a particular post will be useful for the efficient discharge of the duties of post as per DoP&T O.M. No. 15012/2/2010-Estt.(D) dated- 27th March, 2012.

Whereas deficiency memo was issued vide letter No. DE.3(28) / DRC / E-III / TGT / Hindi/Male/2022/ 915 on 17.10.2022 and the reply submitted by the candidate is not upto the merit.

Whereas, Sh. NATWAR LAL JOSHI, D.O.B. 10.08.1988, Roll No. 112503400392 has been provisionally nominated & selected by the DSSSB for appointment to the post of TGT HINDI(Male) post code 34/21 under UR category in Directorate of Education, Govt. of NCT of Delhi.

Whereas during scrutiny of the dossiers it was observed that the candidate is overage and working as Asstt. Teacher in Primary School in Manik pur, vikas khand -Shiv Pur, Distt. Bahraich, Uttar Pradesh.

Whereas, as per point 7 in the advertisement no 02/21, relaxation in upper age upto 05 years for the Departmental candidates with atleast 03 years continuous service as Central Govt. Civilians employees including employees of Govt. of NCT of Delhi in Group B post, will be given which is in the same line or allied cadres and where a relationship could be established that the service already rendered in a particular post will be useful for the efficient discharge of the duties of post as per DoP&T O.M. No. 15012/2/2010-Estt.(D) dated- 27th March, 2012.

Whereas deficiency memo was issued vide letter No. DE.3(28) / DRC / E-III / TGT / Hindi/Male/2022/ 10444 on 14.12.2022 and the reply submitted by the candidate is not upto the merit.

Whereas the service rendered by the candidate as Asstt. Teacher in U.P Govt. is not admissible for relaxation in upper age limit as mentioned in above para, hence, not fit to be selected for the post of TGT (Hindi) Male as per RR's. and other terms and condition in the advertisement."

# REJECTION/ CANCELLATION OF CANDIDATURE IN R/O AVANEESH PATEL FOR THE POST OF TGT(HINDI) MALE UNDER POST CODE-34/21

Whereas, SH. AVANEESH PATEL, D.O.B. 08.09.1993, Roll No. 112003400384 has been provisionally nominated & selected by the DSSSB for appointment to the post of TGT HINDI(Male) post code 34/21 under UR category in Directorate of Education, Govt. of NCT of Delhi.

And whereas, on further scrutiny of dossier of candidate, it was found that candidate has applied and selected in UR Category. However, marks in CTET is 84 in OBC. OBC Certificate is not submitted.

And whereas, a deficiency memo was issued vide letter no. DE.3 (28)/DRC/E-III/TGT (HINDI)/MALE/2022/47659 dated 01.06.2023 and subsequent reminder no. DE.3 (28)/DRC/E-III/TGT (HINDI)/MALE/2022/62905 dated 12.07.2023. In response to this deficiency memo, reply has not been submitted by the candidate.

And whereas candidate has failed to submit CTET certificate with 90 and above marks before cut-off date and/or valid OBC Delhi certificate mandatory required as per RR's and other terms and conditions notified in the advertisement no. 02/21 by the DSSSB. This issue has been considered in this Directorate and found that the candidate has not fulfilling the criteria of UR category as per RR's and other terms and conditions for the post of TGT (Hindi) Male.

And whereas Sh. Avaneesh Patel was not in a possession of valid CTET certificate with 90 and above marks issued on or before cut-off date i.e. 04.07.2021.

Therefore, in view of the above facts and circumstances the candidature of SH. AVANEESH PATEL, D.O.B. 08.09.1993, Roll No. 112003400384 for the post of TGT (Hindi) Male, post code 34/21 of DSSSB advertisement vide no. 02/21 under UR category is hereby Rejected/ Cancelled and his e-dossier returned to the DSSSB, GNCT of Delhi.

#### ORDER

REJECTION/ CANCELLATION OF CANDIDATURE IN R/O RAJU FOR THE POST OF TGT(HINDI) MALE UNDER POST CODE-34/21

Whereas SH. RAJU D.O.B. 01.03.1988, ROLL NO. 111603400254 under UR-PH-VH category has been nominated by the DSSSB for the post of TGT (Hindi) Male under the post code of 34/21 Vide letter No. F.No.4 (612)/DSSSB/CC-I/2021/1049-1055 dated 02.08.2022 (as per vacancy advertisement no.02/21) by the Selection Mechanism Authority i.e. DSSSB vide result notice No 1477 dated. 02.08.2022 and after completion of further course of document verification on the scheduled date and time given in offer of appointment letter and medical examination thereafter. Accordingly, the said candidate was provisionally appointed under provisions of FR-10 and appointment letter was issued.

whereas, as per Appointment Order issued vide no. DE.3(28)/DRC(E-III)/TGT(Hindi)/Male/2022/Pt. File-IX/94 dated 19.04.2023, the Sh. RAJU was required to join the place of posting by the given date, but he did not respond. In continuation of appointment letter, final opportunity letter issued to the said candidate vide letter dated 25.07.2023 and also put in the public domain with the direction to join the duty within stipulated time mentioned in the final opportunity. The joining time has already been expired and candidate fail to join despite of given ample opportunity and the candidate has not joined the duty/present physically before the Competent Authority. Hence, it is concluded that the above said candidate is not interested to join the duty.

As per DoPT Office Memorandum No. 35016/2/93/Estt.(D) dated 09/08/1995 referred para 2, the following has been mentioned.

"An Offer of appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If, however within the specified period a request is received from the candidate for extension of time, it may be considered by the ministry/department but extension beyond 3 months should not be granted liberally."

Therefore as the candidate has willfully chosen not to join his allotted place of posting, hence, the candidature in r/o **SH. RAJU** D.O.B. 01.03.1988, ROLL NO. **111603400254** is hereby cancelled.
