But, name, DOB: 01.07.1985, having Employee ID - 20227634 has Resigned her duty for the post of TGT Hindi Female.

In view of the above facts and circumstances, the act on the part of the aforesaid candidate is taken as refusal to accept the OoA and it is concluded that the candidate is not interested in the appointment to the post of TGT (Hindi) Female, Post Code 33/21 in Level 7 Pay Matrix (Pre-revised Pay Band- 9300-34800 with Grade Pay of Rs. 4600/-) plus usual allowances as admissible under the deemed fit rules.
