ORDER

Cancellation of Candidature for the post of TGT Computer Science-91/20

Whereas, **Mr. AMIT KUMAR, D.O.B. 18.03.1989, ROLL NO. 111609100699, Category UR/PH(OH)**, has been nominated by the DSSSB vide Result Notice No. 134 dated 28.04.2022 to the Post of TGT (COMPUTER SCIENCE) against Post Code - 91/20 and he was given offer of appointment vide this office Memorandum No: DE.4(33)/DRC/E-IV/CST(91/20)/2022/3295 dated 23.06.2022 in the Directorate of Education, Govt. of NCT of Delhi.


And whereas, **Mr. AMIT KUMAR** was issued medical letter and deficiency memo. vide No. 224 & 225 respectively dated 13.07.2022 during document verification. Further, he was issued appointment order with prior approval of Director of Education vide Order No:DE.4(33)/DRC/E-IV/TGT(CS)/(91/20)/2022/8827-38 dated 30.06.2023. However, the Emails dated 22.07.2023 & 11.08.2023 have been received from the candidate (Diary No. 1693/25.07.2023) in this office stating that **"He is not interested in joining as TGT Computer Science in DSSSB and consider this as his final decision."**

As per DOPT OM no. 35016/2/93-Estt.(D) dated 09.08.1995, the following has been mentioned:

*"An offer of appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If, however with the specified period a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond 3 months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only upto a maximum period of 6 months from the date of issue of original offer of an appointment."* An offer of appointment would lapse automatically after the expiry of 6 months from the date of issue of the original offer of appointment.

Therefore, it is evident that the candidate is not willing to join the above mentioned post of TGT Computer Science. Accordingly, the offer of appointment issued to **Mr. AMIT KUMAR, D.O.B. 18.03.1989, ROLL NO. 111609100699, Category UR/PH(OH)**, is hereby withdrawn and his candidature stands cancelled. No further correspondence in this regard will be entertained by this department, in future.
