Whereas, Ms. MONIKA BISHT (22.09.1995) ROLL NO. 324040101533 , Category UR, Dossier No. 294 was provisionally nominated by the DSSSB for the post of TGT (Social Science) under the post code 40/21 vide letter No. F.No.4(43)/DSSSB/CC-IV/2021/2056-2065 dated 24.08.2022 (as per vacancy advertisement no. 02/21) by the selection mechanism authority i.e., DSSSB vide result notice No 169 dated 24.08.2022 and her E-dossier was received from DSSSB for further proceedings of appointment. During the course of documents verification on the scheduled date and time given in the offer of Appointment letter, following deficiencies were noticed: -

1. CTET after cut off date
2. B.Ed. result after cut off date.

In response to the deficiency memo, the candidate submitted the reply vide letter dated 21.04.2023 that she completed her B.Ed. during session 2019-2021. Due to covid-pandemic and declaration of result delayed and CTET notification also not released timely, last notification of CTET released on January 2020, at that time she was not eligible for paper-II CTET.
