**ORDER**

This is in continuation to Public Notice No. F.16/DDE(IEB)/Admn.Cell/Pt. File/2019/657-664 dated 16.01.2023, No. F.16/DDE(IEB)/ Admn.Cell/Pt. File /2019/5772-75 dated 07.07.2023, No.F.146/DDE(IEB)/Admn.Cell//2021/6176-6182 dated 28.07.2023 and F.146/DDE(IEB) /Admn. Cell /2021/ 6803-09 dated 23.08.2023 regarding drawing a panel and engagement of Special Educator (Primary) (Guest) in Govt. schools of DoE for the Academic year 2022-23 and onwards.

Vide the above mentioned Public Notices, detailed guidelines were issued to all the concerned Heads of School regarding eligibility of candidates as per Recruitment Rules and other formalities that are required to be completed prior to joining of Guest teachers. **During the last fortnight, this Branch has received multiple complaints against some newly joined Special Educator (Primary) (Guest) wherein it has been alleged that some candidates not possessing essential qualifications for the post as per eligibility criteria / RRs have been allowed to join in their respective schools by the HoS.** This has been viewed very adversely by the higher authorities.

In view of the above, the Heads of Schools are once again directed to acquaint themselves thoroughly with all the relevant Public Notices/ Orders mentioned above issued by this Branch on the subject matter before verification of the documents of newly joined Special Educator (Primary) (Guest). **All concerned HoS are further directed not to deviate from the eligibility criteria/ approved provisions of RRs while verifying the documents. Strictest compliance is to be ensured by all the HoS in this matter. *If any deviation in respect of eligibility criteria/ approved provisions of RRs for the subject post is observed at a later date, the concerned HoS shall be held responsible the same and appropriate disciplinary action shall be initiated by the Competent Authority.***

***Further, all DDEs (District) shall submit a compliance report as per Public Notices and orders mentioned above to Inclusive Education Branch latest by 25.09.2023.***

For the sake of clarity, the details of eligibility criteria/ approved provisions of RRs for the post of Special Educator (Primary) (Guest) promulgated vide the Public Notices mentioned above are again reproduced below:-

1. XII<sup>th</sup> passed and Two year D.Ed. Special Education in any of the category of disability.  
or  
XII<sup>th</sup> passed and One year Diploma in Special Education (DSE) in any of the category of disability.  
or  
Diploma in Community Based Rehabilitation (DCBR) with 6 months Certificate course in Education of Children with Special Needs.  
or  
Post Graduate Diploma in Community Based Rehabilitation (PGDCBR) with 6 months Certificate course in Education of Children with Special Needs.

or

Diploma in Multi Rehabilitation Worker (MRW) with 6 months Certificate Course in Education of Children with Special Needs.

or

Junior Diploma in Teaching the Deaf.

or

Primary level Teacher Training course in Visual Impairment.

or

Diploma in Vocational Rehabilitation-Mental Retardation (DVR-MR)/Diploma in Vocational Training and Employment Mental Retardation (DVTE-MR) with 6 months Certificate course in Education of Children with Special Needs.

or

Diploma in Hearing Language and Speech (DHLS) with 6 months Certificate course in Education of Children with Special Needs.

or

XII<sup>th</sup> passed with any RCI recognized qualification of minimum one year duration and 6 months Certificate course in Education of Children with Special Needs.

or

Any other equivalent qualification approved by RCI.

2. Qualified in Central Teacher Eligibility Test (CTET) (Primary stage) conducted by Central Board of Secondary Education (CBSE). Relaxation upto 5% in the qualifying marks shall be allowed to candidates belonging to reserved categories such as SC/ST/OBC/PH in CTET.
3. Registration with Rehabilitation Council of India (RCI).
