ORDER

Cancellation of offer of Appointment and candidature to the post of TGT(ENGLISH) FEMALE, Post Code 51/21

Whereas, **Ms. Pooja Singh, D.O.B. 25.10.1996, Roll No. 112005100543, Employee ID 20232625, Category EWS,** has been nominated by the DSSSB to the post of TGT (ENGLISH)-FEMALE against Post Code 51/21 vide Result Notice No. 1408 dated 20/07/2022 in the Directorate of Education, Govt. of NCT of Delhi.

And whereas, **Ms. Pooja Singh** was directed to report to respective place of posting latest by 31.07.2023. A final notice was issued by this department on 04.09.2023 to **Ms. Pooja Singh** with the directions to report to respective place of posting latest by **07.09.2023**, but as per office record, **Ms. Pooja Singh** has not joined the duty till date.

As per DOPT OM no. 35016/2/93-Estt.(D) dated 09.08.1995, the following has been mentioned:

"An offer of appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however with the specified period a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond 3 months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only upto a maximum period of 6 months from the date of issue of original offer of an appointment". An offer of appointment would lapse automatically after the expiry of 6 months from the date of issue of the original offer of appointment.

Therefore, it is evident that the candidate is not willing to join the above-mentioned post of TGT (English) Female. Hence, the Director (Education) being the Competent Authority ordered to **cancel** the candidature of **Ms. Pooja Singh, D.O.B. 25.10.1996, Roll No. 112005100543, Employee ID 20232625, Category EWS, Post TGT (ENGLISH)-FEMALE, under post code 51/21** and return her dossier to the DSSSB.
