ORDER

Cancellation of candidature for the post of TGT Math (Male), Post Code -38/21

Whereas, the Candidate namely ASHWANI PAL, Roll No. 111403800020 (Category UR) was nominated for the post of TGT Maths (Male) under post code-38/21 (as per vacancy advertisement no. 02/21) by the Selection Mechanism Authority i.e. DSSSB vide Result notice no. 1473 dated 27-07-2022 and his Dossier was received from DSSSB for further proceedings towards consideration of appointment for aforesaid post. Accordingly, a memorandum i.e. Offer of Appointment dated 18/10/2022 was issued.

And Whereas, after successfully completion of verification of documents, ASHWANI PAL (Emp. Id: 20231782) was issued provisional appointment under FR-10 vide Order No. F.No. DE 3(32)/DRC/E-III/TGT(Math)/MALE/2022/85 dated 19/04/2023 posting ID 20230413 to the post of TGT Math (Male) with the direction to join his duties at assigned place of posting latest by 19/05/2023 failing which his appointment shall stand cancelled without any further communication.

Further, ASHWANI PAL was also granted final opportunity vide letter dated 18 JULY 2023 (with the prior approval of the competent authority) and also put in the public domain with the directions to join his duties at assigned place of posting latest by 24/07/2023 and to submit a copy of his joining in DRC (E-III Branch) failing which his candidature for the aforesaid post will be cancelled without any further notice. No representation/request in written was received from the candidate for extension of joining time.

As per DoPT Office Memorandum No. 35016/2/93/Estt.(D) dated 09/08/1995 para 2 :-

*"An Offer of appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however within the specified period a request is received from the candidate for extension of time, it may be considered by the ministry/department but extension beyond 3 months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only upto a maximum of six months from the dated of issue of the original offer of appointment. And offer of appointment would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment"*

Therefore, in view of the above facts and circumstances and since the candidate has willfully chosen neither to join the duties at concerned allotted school even after issuing final opportunity memo, the 'Provisional Appointment Order dated 19-04-2023 issued to ASHWANI PAL vide Posting ID. 20230413 is hereby withdrawn and candidature of the aforesaid candidate stands cancelled accordingly with the retrospective date of 'Offer of Appointment'.
