DE.3(41)/DRC(E.III)/TGT(Sanskrit)/Male/2022/27 dated 01/09/2022 after successful document verification held on 12/08/2022.

And Whereas, after declaring medically fit by Sanjay Gandhi Memorial Hospital he has been appointed to the post of TGT(Skt.) Male vide order no. DE.3(41)/DRC(E.III)/TGT(Sanskrit)/Male/2022/731dated 18/04/2023.

And Whereas, he has been posted and joined at SBV-1412092, Nithari Village on 01/09/2022.

And Whereas, as per letter of Kendriya Vidyalaya Sangthan, Dhar Road, Udham Pur, J&K Shri Satish Kumar S/o Darvesh, R/O VPO Karsindhu, Tehsil Narwan, District-Jind-126115, Haryana was selected as TGT(Skt.) in Kendriya Vidyalaya Sangthan.

And Whereas, Offer of Appointment for the post of TGT(Skt.) was issued by Kendriya Vidyalaya Sangthan(Regional Office), Ranchi vide letter no. F.40042/KVS/R.O./(Ranchi)/Appointment/2019-20/7133-34 dated 20/08/2019 and posted at Kendriya Vidyalaya, Jamtara(Jharkhand).

And Whereas, Shri Satish Kumar joined as TGT (Sanskrit) as on 04/09/2019 at Kendriya Vidyalaya, Jamtara(Jharkhand).

And Whereas, vide letter No. F.11-E-11043/2/2021-Estt-11/No Taker Transfer/dated 31/10/2021, Shri Satish Kumar was transferred to Kendriya Vidyalaya 2, Udhampur.

And Whereas, Shri Satish Kumar joined at Kendriya Vidyalaya 2, Udhampur as on 08/11/2021(F/N).

And Whereas, Shri Satish Kumar submitted his resignation on 09/09/2022 through email and letter sent through speed post which was received on 24/09/2023.

And Whereas, Shri Satish Kumar left the station without submitting proper "No Dues Certificate".

And Whereas, his application of resignation was rejected by the appointing authority vide letter no. F.24029/Resig/2020/KVS(J.S.)/Admn./dated 26/09/2022 because of minor penalty "Reduction of pay by one stage for a period of two years w.e.f. 05/04/2021 without cumulative effect" imposed by the competent authority on dated 05/04/2021.

And Whereas, Shri Satish Kumar S/o Darvesh, R/O VPO Karsindhu, Tehsil Narwan, District-Jind-126115, Haryana informed KVS that he has been selected as TGT(Skt.) vide letter no. DE.3(41)/DRC(E.III)/TGT(Sanskrit)/Male/2022/1725 dated 08/08/2022.

And Whereas, you are still on the roll and on strength of Kendriya Vidyalaya 2, Udhampur and not relieved from Kendriya Vidyalaya Sangthan.

And Whereas, it seems that you hide the information about your appointment in Kendriya Vidyalaya Sangthan intentionally and joined as TGT(Skt.) Male in Directorate of Education in Govt of

NCT of Delhi without getting relieved from your place of posting/KVS. You also not informed intentionally the department about the penalty imposed upon you by KVS.

And whereas, you also violated the terms and conditions mentioned in offer of appointment and given incomplete information in attestation form at the time of document verification held on 12-08-2022 which makes your integrity doubtful.

Therefore, Shri Satish Kumar, TGT(Skt.) Male is hereby directed to explain the reason for above said lapses within 03 days of receipt of this notice and why his service should not be terminated as per Rule 5 of the Central Service (temporary service) Rules 1965. If the reply is found without substance, then Directorate of Education reserve right to initiate disciplinary action under Rule 5 of the Central Service (temporary service) Rules 1965. without giving further notice.
