ORDER

Cancellation of offer of Appointment and candidature to the post of TGT(ENGLISH) FEMALE, Post Code 51/21

Whereas, **Ms. Vaniti, DoB 13.06.1988, Roll No. 111605100142, Category UR**, has been nominated by the DSSSB to the post of TGT (ENGLISH)-FEMALE against Post Code 51/21 vide Result Notice No. 1408 dated 20/07/2022 in the Directorate of Education, Govt. of NCT of Delhi and their e-dossiers received from DSSSB for further proceedings of appointment. During the Document verification, following deficiencies has been found:

1. CTET marksheet is required.
2. In B.Com. (duration 2007-2009), the candidate has not studied English, however candidate has studied English as Additional subject in the year 2013-14, hence clarification is required. Degree of Additional subject English is also required.
3. NOC from previous department with supporting documents is required.

This office had issued Deficiency Memo to **Ms. Vaniti** on 22.06.2023 and subsequent reminder dated 21.08.2023, to clear the deficiency. However, the deficiency has not been removed by **Ms Vaniti** till date.

Ms Vaniti has submitted CTET Marksheet and Service/Vigilance Certificate, issued by District & Session Judge, Rewari i.e. her previous department, copy of Medical Certificate, Police Verification Report and copy of Service Book.


In **B.Com** (duration 2007-2009), **Ms Vaniti** has not studied English. However, she has studied English as an **additional subject** in **B.A.** in the year 2013-14 of which Degree is not submitted.

In similar cases, an Expert committee was constituted to examine the eligibility of the such candidates for the post of TGT English Female, Post Code 51/21, as per the Recruitment Rules published vide Gazette No. 44 dated 27/02/1997 and Vacancy notice published by DSSSB vide Advt. No. 03/2021 dated 27/05/2021.

The Expert Committee examined the candidate's acquired qualification through dossier/ certificates and unanimously in their view that as per RR's English must be studied for two years/four semesters and given their observation that the candidate cannot be considered for the post TGT English Female as the candidate has not studied English in Graduation (i.e. **B.Com.**).

Hence, the Director (Education) being the Competent Authority ordered to **cancel** the candidature of **Ms. Vaniti, DoB 13.06.1988, Roll No. 111605100142, Category UR, Post TGT (ENGLISH)-FEMALE, under post code 51/21** and return her dossier to the DSSSB.




