Cancellation of Candidature for the post of TGT Computer Science-91/20


In continuation of this Office Memorandum No. **DE.4(33)/DRC/E-IV/CST(91/20)/2022/5598 Dated 27/04/2023** and subsequent reminders dated **07/07/2023, 21/07/2023** vide which the offer of appointment was issued to **Ms. SUMAN SHARMA, (Roll No.-112009101138), D.O.B-12/06/1995, Category-ST** and final opportunity dated **09/08/2023** was issued to the candidate with the direction to submit her acceptance against the offer of appointment to the undersigned within the stipulated time and report personally along with relevant documents mentioned in the offer of appointment letter. However, neither any acceptance nor any reply has been received till date.
