All concerned HoS, Dte. of Education, GNCTD are directed to ensure that the reporting Guest Teacher(s) is having the Experience Certificate of her/his working days and also possessing requisite qualification according to the prevailing notified RRs for the post, before allowing joining of their duties in the School.

The HoS, are further directed to ensure that Guest Teacher(s) from **Table-B are to be relieved immediately**, only when Guest Teachers from **Table-A reports to the respective allocated** School mentioned against their name and if not so, the **non-relieving of such Guest Teacher from Table-B will be viewed seriously and ID of Guest Teacher concerned will be blocked** and Show Cause Notice will be issued to the HoS concerned.

Further, engagement of Guest Teachers is a stop gap arrangement and does not confer any right for permanent joining. The Guest Teachers shall be relieved once a permanent teacher joins the school.
