**ORDER**

**Cancellation of Candidature for the post of Drawing Teacher -91/17**

Whereas, Ms. Geeta (D.O.B: 06.07.1992) ROLL NO. 110909100212, Category OBC was provisionally nominated by the DSSSB for the post of Drawing Teacher under the post code 91/17 (as per vacancy advertisement no. 04/17) by the selection mechanism authority i.e., DSSSB and E-dossier was received from DSSSB for further proceedings of the appointment. During the course of scrutiny of documents, following deficiency was noticed. Therefore, a deficiency memo vide letter No.F.DE.4(34)/DRC/E-IV/Drawing Teacher (91/17)/2022/5740 dated 09-05-2023 was issued: -

The qualifications possessed by the candidate is not as per RRs for the post of DRAWING TEACHER. The candidate is required to submit any one of the following documents: -

*Five years diploma in Drawing/Painting/Sculpture/Graphic Art from a University/Institute recognized by the Government of India.*

OR

*Master's Degree in Drawing and Painting/Fine Art from a recognized University.*

OR


*Bachelor's Degree in Drawing/Painting/Fine Art plus Two years Full time diploma in Painting/Fine Art from a recognized University/Institution.*

And subsequent reminders dated 08.06.2023, 20.06.2023 & final reminder dated 03.07.2023 were issued to Ms. Geeta (D.O.B: 06.07.1992) ROLL NO. 110909100212, Category OBC. In response to the deficiency memo dt 03.07.2023, the candidate has requested to cancel her candidature vide email correspondence dt. 13.07.2023.

Keeping in view of the above facts & circumstances, the candidature of the above candidate stands cancelled accordingly. The concerned E-dossier file is being returned to DSSSB for further necessary action at their end.

**ORDER**

**Cancellation of Candidature for the post of Drawing Teacher -90/20**
