## **CORRIGENDUM**

This is in continuation to the Cancellation Order number F.No. DE. 3(29/DRC/E-III/TGT(Natural Science)/Male/2022/68700 dated 27.07.2023 wherein a cancellation of candidature in r/o Mr. **Joginder Kumar** (DOB – 16.05.1987), Roll No. 111503500131 was issued. There are some facts of the case which could not be incorporated in order dated 27.07.2023.

Now, in partial modification to the aforesaid cancellation order dated 27.07.2023, the following amendments are given as under: -

5	And whereas, in this regard, an opportunity was given to <b>JOGINDER KUMAR</b> by issuing Deficiency Memo number F. No.DE.3 (29)/DRC/E-III/TGT (NATURAL SCIENCE)/MALE/2022/1774 dated 07.02.2023 in which he was asked to submit clarification/requisite/deficient documents within 15 days. After taking time for submission of requisite document vide applications dated 22.02.2023, 06.03.2023, the candidate submitted final reply on 16.03.2023 alongwith a copy of digitally signed OBC Certificate No. 905000008399	And whereas, in this regard, an opportunity was given to <b>JOGINDER KUMAR</b> by issuing Deficiency Memo No. 683 dated 16.12.2022 in which he was asked to submit clarification/requisite
	51 dated 06.04.2022 (i.e. after Cutoff Date) issued on Delhi Based Residency by Ex. Magistrate (Rohini), Delhi (surprisingly, this certificate was not presented by the candidate before assigned DV Team during 'Document Verification Campaign'), a copy of Certificate dated 15.03.2023 of Ex. Magistrate (Rohini) by providing the clarification as "OBC Certificate dated 06.04.2022 has been issued fresh in lieu of old caste certificate No.90500000498549 dated 30.01.2019 as the old caste certificate could not be rectified as there is no such provision	/deficient documents. The candidate submitted reply on 01.02.2023 with Disability certificate having 43% disability. However, the certificate issued dated 01.02.2023 will be counted as 'After
	in online mode" and other supporting documents as a proof that candidate & his family were resided in Delhi since	cut-off date i.e. 04.07.2021'.



before 1995, with the request to dispose the raised deficiency and issue Medical Examination Letter and Appointment Order.

It has been decided by the Competent Authority that the later on produced OBC Certificate No. 90500000839951 dated 06.04.2022 will be counted as after 'Cutoff Date', however, the same was mandatory to be issued 'On or Before Cutoff Date i.e. 04.07.2021' as per eligibility criteria of Point No. 5 and Point No. 6(ii), 6(iv) according to Vacancy Notice Advertisement No. 02/2021 dated 12.05.2021 and RRs.

Rest of the contents of the aforesaid Order will remain the same.
