CANCELLATION ORDER

Whereas, vide Vacancy Notice Advertisement No.02/21 dated 12.05.2021, the DSSSB advertised the vacancies for the post of TGT (Natural Science) – Male under Post Code 35/21.

And whereas, reference to aforesaid vacancy, Mr. **DEEPAK KUMAR** (DOB – 06.01.1995), Roll No. 112503500563, a candidate of 'OBC' Category was nominated by the DSSSB for the post of TGT (Natural Science) - Male under the Post Code of **35/21** by the Selection Mechanism Authority i.e. DSSSB vide their Result Notice No 145 dated 28.07.2022 and his e- dossier was forwarded for further proceedings of Appointment.

And whereas, after the preliminary scrutiny of documents available in e- dossier, a Memorandum towards 'Offer of Appointment' was issued on 13.12.2022 to the aforesaid candidate with the directions to appear in person on the scheduled Date, Time and Venue alongwith all the requisite documents for Document Verification.

And whereas, it was observed during the course of documents verification conducted on 19.12.2022 by the assigned Team that the aforesaid candidate does not possess following requisite documents: -

- 1. NCTE Certificate is required (Candidate possess B.Ed. Degree from Singhania University, Jhunjhunu, Rajasthan).
- 2. NCL Certificate on or before Cut Off Date i.e. 04.07.2021 is required.
- 3. NOC from present Department is required.

And whereas, in this regard, an opportunity was given to the Mr. **DEEPAK KUMAR** by issuing Deficiency Memo No F. No.DE.3 (29)/DRC/E-III/TGT/ NATURAL SCIENCE/(MALE)/2022/906 dated 19.12.2022 vide which he was asked to submit clarification alongwith requisite/deficient documents.

And whereas, in response to the aforesaid Deficiency Memo, the candidate vide his replies/representations dated 03.01.2023 & 12.04.2023 submitted a certification dated 31.12.2022 issued by concerned Tehsildar regarding validity of NCL Certificate before Cutoff Date as well as NOC from the previous Department respectively and the same are acceptable. The candidate also enclosed copy of two judgements dated 21.02.2018 (S.B. Civil Writ Petition No. 9198/2017), dated 25.03.2021 (S.B. Civil Writ Petition No. 12386/2020) of Hon'ble High Court, Jodhpur, Rajasthan and request to remove the raised deficiency reg. NCTE Certificate on the basis of Court's decisions, however, judgements of Hon'ble Court in aforesaid cases are not relevant/ applicable for the Post Code-35/21. The candidate further requested to consider his case for Appointment by exempting the NCTE Certificate. According to a letter of NCTE dated 19.04.2023 wherein they have clarified that "Singhania University, Jhunjhunu, Rajasthan was never recognized by NRC, NCTE for conducting B. Ed. Degree/ Course, means "the candidate where he studied B. Ed. Degree/ Course is not recognized by NRC, NCTE and he does not possess valid NCTE Certificate which is mandatory as per prevailing RRs/ Guidelines/ Instructions to the aforesaid post".

Keeping in view of the above facts & circumstances, it is clear that aforesaid candidate is not eligible to be appointed for the post of TGT (Natural Science) — Male, Post Code 35/21, therefore, the candidature/nomination of Mr. DEEPAK KUMAR (Roll No 112503500563), a candidate of 'OBC' category is hereby withdrawn/rejected accordingly as the aforesaid candidate does not fulfil the required eligibility criteria according to Vacancy Notice Advertisement No.02/21 dated 12.05.2021/RR's & prevailing other terms and conditions.

"No claim for Appointment, if so, made at any later stage on the basis of any ground by any candidate will be entertained by the Department, in future."

This issues with the prior approval of the Competent Authority.
