**CANCELLATION ORDER**

**Cancellation of Offer of Appointment to the post of EVGC (Male)**  
**Post Code 35/20**

Whereas **Mr./Sh. Sonoo (DOB- 05/07/1993), (Roll No. 121103500156)** has been nominated by the DSSSB for the post of EVGC (Male) against Post Code 35/20 vide letter No.F.4(273)/P&P/DSSSB/2019/653 dated 19/05/2022 vide Result Notice No. 846 dated 05/05/2022 and accordingly an Offer of Appointment was issued to him vide this Directorate Memorandum of even No. 923 dated 23/05/2023, the second opportunity given to him vide Reminder-1 Memorandum of even No. 1457 dated 13/07/2023 and Final Opportunity given to her vide Memorandum of even No. 1672 dated 17/08/2023.


And whereas, Mr./Sh. Sonoo did not report in person on the scheduled date and time as given in the offer of appointment issued to him vide letter of even no. 923 dated 23/05/2023, reminder-1 of even no. 1457 dated 13/07/2023 and Final Opportunity of even no. 1672 dated 17/08/2023. He has neither accepted the offer of appointment nor intimated any reason to D.R. Cell E-II for not accepting the offer of appointment and not reporting on said scheduled date and time.

As per DoPT Office Memorandum NO. 35016/2/93-Estt. (D) dated 09/08/95 wherein para 2, the following has been mentioned:

"An Offer of Appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If, however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond three months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and, in any case, only up to a maximum period of six months from the date of issue of the original offer of an appointment". **An offer of appointment would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment.**

Therefore, in view of the facts and circumstances as above and since the candidate has wilfully chosen not to respond to the memorandums dated 23/05/2023, reminder-1 dated 13/07/2023 and Final Opportunity dated 17/08/2023. The candidature in respect of Mr./Sh. Sonoo (Roll No. 121103500156) is hereby cancelled, and his dossier returned to the DSSSB.
