The concerned Municipal Authorities shall ensure that the teacher is relieved to assume the charge of promotional post by 10th November, 2023 after ensuring that there is no vigilance case /departmental enquiry pending / no penalty in operation against the teacher at any level at the time of relieving to assume the charge of promotional post. It should be specifically/ clearly mentioned in the relieving order of the promoted teachers that no vigilance case is contemplated/ pending against her at any level. If any discrepancy, the concerned MCD authorities may contact in E-III Branch, Directorate of Education, GNCTD. This issues with the prior approval of the Competent Authority.
