ORDER

Cancellation of Candidature for the post of Assistant Teacher (Primary)-42/21

In continuation of this Office Memorandum No. F.DE.4(49)/DRC/E-IV/PRT(42/21)/2023/14387 Dated 11.09.2023 and subsequent reminder dated 20.09.2023, vide which the offer of appointments were issued to Mr. Sonu Poonia (Roll No. - 111104202307) S/o Mr. Attar Singh and final opportunity dated 09.10.2023 was issued to the candidate with the direction to submit his acceptance against the offer of appointment to the undersigned within the stipulated time and report personally along with relevant documents mentioned in the offer of appointment letter. However, neither any acceptance nor any reply has been received till date.

The above act on the part of the candidate is being taken as refusal to accept the offer of appointment and it is presumed that the candidate is not interested in the appointment to the post of Assistant Teacher (Primary), under post code-42/21 in Level 7 Pay Matrix (Pre-revised Pay Band - 9300-34800 with Grade Pay of Rs. 4200/-) plus usual allowances as admissible under the Rules.

ORDER

Cancellation of Candidature for the post of Assistant Teacher (Primary)-42/21

Whereas, Mr. Riazur Rehman Shamsi, Roll No. 121104217137, Category UR was provisionally nominated by the DSSSB for the post of **Assistant Teacher (Primary)** under the post code 42/21 vide letter No.F.DE.4(49)/DRC/E-IV/PRT(42/21)/2023/1662 dated 23/12/2022 (as per vacancy advertisement no. 02/21) by the selection mechanism authority i.e., DSSSB vide result notice No. 1489 dated 02.11.2022 and his E-dossier was received from DSSSB for further proceedings of appointment. During the course of documents verification on the scheduled date and time given in the offer of Appointment letter, following deficiency vide letter No. F.NO.DE.4(49)/DRC/E-IV/PRT(42/21)/2023/600 dated 17.07.2023 was noticed: -

1. Clarification regarding completion of degree as it is mentioned in the certificate that the degree is partially cleared.

And whereas, in response to the deficiency memo, neither any clarification nor requisite/deficient documents were submitted by the candidate.

And whereas, candidate has replied that he is not interested to join Directorate of Education for the post of Assistant Teacher Primary on official mail dated 17.10.2023.

Keeping in view of the above facts & circumstances, the offer of appointment issued to the candidate is hereby withdrawn and the candidature of the above candidate stand cancelled accordingly with retrospective date of OOA, if any issued to the candidate. The concerned E-dossier file is being returned to DSSSB for further necessary action at their end.
