ORDER



The promotion is subject to the condition that the teachers fulfill all the requirements as laid down in the Recruitment Rules of Domestic Science Teacher in this Directorate and is further subject to the condition that there is no vigilance case/departmental enquiry pending or no penalty is in operation against the teacher concerned at any level.

However, the above promoted teachers will not be entitle to the payment of pay and allowances for the period for which they would not have actually worked. The benefit will be admissible w.e.f. the actual date of their joining to the promotional post. They will avail benefit of promotion on their joining duty in this Directorate.

The promotion shall remain subject to out of SLP (C ) No. 30621/2011 and connected SLPs pending before the Hon'ble Supreme Court

The above mentioned teachers may exercise their option with regard to fixation of pay , if any, as per FR-22 within one month of issue of this order. The concerned HOD/MCD should ensure that no disciplinary proceedings are pending against any of the above mentioned teacher before reliving them to take up their new assignment on promotion if any teacher out of the above is not clear from Vigilance angle as on date or has resigned /relived/expired etc. the same should be brought to the notice of this department immediately.
