**Cancellation of offer of Appointment and candidature to the post of PGT(ECONOMICS) MALE,
POST Code 66/20**

Whereas, **Sh. RAMSWAROOP MEENA, D.O.B. 20/02/1993, Roll No. 111306600015** has been nominated by the DSSSB to the post of PGT(ECONOMICS)-MALE against Post Code 66/20 vide Result Notice No.1419 dated 22/12/2021 in the Directorate of Education, Govt. of NCT of Delhi.

Whereas, the candidate was appointed/posted at Paschim Vihar, A 6-G(Co-ed)SSS-1617032 vide Order No: F.NO.DE-2(63)/DRC(E-II)/PGT(ECONOMICS)/MALE/2021/3643 dated: 31/05/2023 (Posting ID: 20230451), with the direction to join his place of posting latest by 01/07/2023.

Whereas, Final Notice (last opportunity) of joining vide Order No: F.NO.DE-2(63)/DRC(E-II)/PGT(ECONOMICS)/MALE/2021/1750 dated: 11/09/2023 to join till 18/09/2023 was issued.

Whereas, it is found that the candidate has not joined his allotted school till date.

As per DOPT OM no. 35016/2/93-Estt.(D) dated 09.08.1995, the following has been mentioned:

"An offer of appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however with the specified period a request is received from the candidate for extension of time, It may be considered by the Ministry/Department but extension beyond 3 months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only upto a maximum period of 6 months from the date of issue of original offer of an appointment". An offer of appointment would lapse automatically after the expiry of 6 months from the date of issue of the original offer of appointment.

Therefore it is evident that the candidate is no longer interested in joining the above mentioned post. Hence, the Director (Education) being the Competent Authority ordered to **cancel** the candidature of **Sh. RAMSWAROOP MEENA, D.O.B. 20/02/1993, Roll No. 111306600015, post PGT (ECONOMICS)-MALE** and return his dossier to the DSSSB.

This issues with the prior approval of the Competent Authority.


