CANCELLATION ORDER

Cancellation of Appointment and Candidature to the post of PGT History (Male)

Post Code 112/17

Whereas **Mr. Yogesh (DOB- 09/04/1977), (Roll No. 2040009448)** has been nominated by the DSSSB for the post of PGT History (Male) against Post Code 112/17 vide letter No.F.1(411)/DSSSB/P&P/2017/4659 dated 25/01/2021 and Supplementary Result Notice No. 718 dated 27/11/2020 and accordingly after the successful verification of documents, he was appointment/posted at Mangolpuri, Block R-SBV-1412011 vide appointment order No. DE.2(11)/DRC(E-II)/PGT (History)/Male/2019/Pt. I/3092, Posting ID 20230011, Employee ID 20230891 and was required to join his respective place of posting in prescribed time.

Whereas, Notice for Joining (Last Opportunity) vide order no. DE-2(94)/DRC/E-II/Extension/2023/1922 dated 12.10.23 to join his place of posting by 21/10/2023 was issued.


And whereas, **Mr. Yogesh (Employee ID - 20230891)** did not join/report his respective place of posting i.e., Mangolpuri, Block R-SBV-1412011 in the prescribed time as mentioned in Notice for Joining (Last Opportunity).

As per DoPT Office Memorandum NO. 35016/2/93-E:stt. (D) dated 09/08/95 wherein para 2, the following has been mentioned:

“An Offer of Appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If, however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond three months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and, in any case, only up to a maximum period of six months from the date of issue of the original offer of an appointment”. **An offer of appointment would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment.**

Therefore, in view of the above facts and circumstances the appointment and candidature in respect of **Mr. Yogesh (Employee ID - 20230891)** for the **post of PGT History (Male) & Post Code-112/17** is hereby **cancelled**, and his dossier returned to the DSSSB.
