**Cancellation of offer of Appointment and candidature to the post of PGT(MATHS)
MALE, POST Code 28/20**

Whereas, **Sh. Virender, D.O.B. 21/06/1981, Roll No. 121102800876** has been nominated by the DSSSB to the post of PGT(MATHS)-MALE against Post Code 28/20 vide Result Notice No.855 dated 10/05/2022 in the Directorate of Education, Govt. of NCT of Delhi. During the course of preliminary scrutiny of e-Dossier received from DSSSB, it is found that the candidate is claiming age relaxation **under 'UT sub-category' i.e. University Teacher.**

And whereas, as per DSSSB Advt. 02/2020:-05 years of age relaxation to "those who are Teaching in University" may be given which is at par with the age relaxation given to Govt. Servant for posts which are in the same line or allied cadres as per DoP&T OM No. 15012/2/2010-Estt.-D dated 27/03/2012 (Sr. No. 12) which states that:

*"5 years of age concession is available to Departmental Candidates with three years **continuous service** in Central Government for posts which are in the same line or allied cadres and where a relationship could be established that the service already rendered in a particular post will be useful for the efficient discharge of the duties of post".*

And whereas, Deficiency Memorandum vide letter no. F.NO.DE-2(55)/DRC(E-II)/PGT(MATHS)/MALE/2021/Part-V/1466 dated: 17/07/2022 and no. 1604 dated: 04/08/2023 was issued to him for clarification regarding his claim of age relaxation **under 'UT sub-category**. In this regard candidate replied "*Ad hoc service of University of Delhi is a kind of arrangement to avoid the loss of any teaching in University & its Colleges. The Ad hoc Service carries full pay-scale with other admissible allowances. It has a Notional break of 1 day after 120 days*".

And whereas, the Principal, Ramjas College, Delhi University (where candidate worked as an Assistant Professor on adhoc basis) and the Deputy Registrar (Colleges) of University of Delhi stated that "*The Ad-hoc appointment shall only be made for a period of more than one month and up to four months (i.e. 120 days) in accordance with the provisions contained in clause 3(1) of ordinance XII.*"

Therefore, in view of the facts and circumstances as above, the candidature of **Sh. Virender D.O.B. 21/06/1981, Roll No. 121102800876** for the post of PGT(MATHS)-MALE against Post Code 28/20 is hereby cancelled and his dossier returned to the DSSSB.

This issues with the prior approval of the Competent Authority.
