During the course of documents verification on the scheduled date and time given in the Offer of Appointment letter, following deficiencies were noticed: -

- 1. As per RR of TGT Social Science B-Ed. Educational Documents are required as the candidates has completed her B-Ed. in Special Education in year 2020.
- 2. NCTE Certificate is required.

In response to the deficiency memo, she replied vide her letter dated 25/07/2023 but she has failed to submit the requisite documents.

Whereas, it was found the she possessed a degree of Bachelor of Education (Special Education-LD) instead of B.Ed. Degree which is not considerable for appointment of TGT (Social Science) Female.

Keeping in view of the above facts & circumstances, the offer of appointment issued to her, is hereby withdrawn and the candidature of the above candidate stands cancelled accordingly with retrospective date of OOA. The concerned E-dossier file is being returned to DSSSB for further necessary action at their end.

"No claim for appointment, if so, made at any later stage on the basis of any ground by any candidate will be entertained by the department, in future."
