ORDER

CANCELLATION OF CANDIDATURE FOR THE POST OF TGT(SOCIAL SCIENCE)
FEMALE POST CODE-40/21

Whereas **Amita**, D.O.B. **30.08.1990**, Category OBC, Dossier No. OBC-WL-18, ROLL NO. 411040105411 was nominated by the DSSSB for the post of TGT (Social Science) Female under the post code of 40/21 vide letter No. F.No.4 (43)/DSSSB/CC-IV/2021/2056-2065 dated 24.08.2022 (as per vacancy advertisement no. 02/21) by the Selection Mechanism Authority i.e. DSSSB vide result notice No 169 dated. 24.08.2022 and accordingly the offer of appointment was issued to the candidate vide this Directorate's Memorandum dated 31.07.2023 for documents verification on 04.08.2023. During the documents verification, she was issued a Deficiency Memo with the direction to submit the requisite documents/clarification within 07 days vide letter dated 04.08.2023 for the following deficiencies: -

(1) One attestation form is required (2) 3 Sets of attestation form is required (3) NCL Certificate before cut of date 2021-22, 2022-23 & 2023-24 is required (4) NCTE Certificate is required (5) CTET marksheet is required (6) NOC from current department is required (7) Photocopy of Service Book first page and attested copy of joining report, medical report and police verification entered in service book by Head of Office.

And whereas, **Amita** did not submit/reply the requisite deficiencies in response to aforesaid Deficiency Memo dated 04.08.2023. She were issued three reminders vide letters dated 12.09.2023, 19.09.2023 and 27.10.2023.

As per DoPT Office Memorandum No. 35016/2/93/Estt.(D) dated 09/08/1995 referred para 2, the following has been mentioned.

"An Offer of appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however within the specified period a request is received from the candidate for extension of time, it may be considered by the ministry/department but extension beyond 3 months should not be granted liberally."

Therefore, in view of the above facts & circumstances as stated above and since the candidate has failed to submit the reply/requisite documents/ clarification inspite of issuance of Deficiency Memo dated 04.08.2023, Reminder-I 12.09.2023, Reminder-II dated 19.09.2023 and Reminder-III/Final Reminder dated 27.10.2023. Therefore, the candidature in r/o **Amita** is hereby cancelled and dossier is returned to DSSSB.

"No claim for appointment, if so, made at any later stage on the basis of any ground by any candidate will be entertained by the department, in future."

This issues with the prior approval of the Competent Authority.
