**ORDER**

**CANCELLATION OF CANDIDATURE FOR THE POST OF TGT (SANSKRIT) FEMALE, POST CODE -55/21**

**Whereas**, Ms. ANITA (DOB: 05/02/1982), having Roll No. 112005500004 was provisionally nominated by the DSSSB for the post of TGT SANSKRIT (FEMALE), Post Code – 55/21 vide result notice 167 dated 16/08/2022 under UR-PH-OH category.

**Whereas** at the time of scrutiny of the documents, it came to notice that the Disability certificate is issued on 04/03/2022 which is after cutoff date. However, the candidate uploaded a General Diary report dated 16/01/2022, PS- Arya Nagar, Rohtak, Haryana regarding loss of Disability Certificate. Therefore, another Deficiency Memo was issued to Ms. Sarita on 11/01/2023 for the following deficiencies:

- i) Disability Certificate before Cutoff date is required.
- ii) Name of B.Ed College is not mentioned in B.Ed Marksheet and Degree.

**Whereas**, in response to the above said Deficiency Memo, the candidate submitted following documents on 15/02/2023:

- i) Copy of a Medical cum Disability Certificate issued before cutoff date in the name of Sarita W/o Satwan.
- ii) Affidavit declaring that Anita & Sarita both are the same person and Anita is her right name in all documents.
- iii) Certificate issued by the Principal, R.S. Memorial College of Education wherein it is certified that the candidate appeared in B.Ed Exam as a private candidate in KUK in the session 2013-14.

**Whereas**, observation of Medical cum Disability Certificate no. 1543 dated 03/09/1997 submitted by the candidate revealed that the said certificate is issued in the name of Sarita W/o Satwan and the name Anita was added as Sarita *alias* Anita which seems to be written after the issuance of the certificate and created doubt of over write on the Disability Certificate as the name "Sarita" was not mentioned in any of the document of the candidate Ms. Anita.

**Whereas**, Deputy Civil Surgeon, Sonipat, Haryana vide his letter dated 27/04/2023 informed that as per their record, the disability certificate No. 1543 dated 03/09/1997 has been issued by District Medical Officer on behalf of Civil Surgeon, Sonipat, Haryana in the name of Sarita W/o Sh. Satwan, Village Ahulana.

**Whereas**, another discrepancy also came to the notice that as per date of Birth i.e. 05/02/1982 mentioned in her educational documents, her age should have been 15 years while obtaining the disability certificate in the year 1997, whereas her age mentioned in the disability certificate is 20 years. Clarification was sought from the candidate Ms. Anita vide letter dated 17/07/2023. Ms. Anita vide her letter diary no. 3677 dated 02/08/2023 informed that she is unable to produce the Disability Certificate issued before cut-off date and further stated that the Department is free to take decision in this matter.

**Whereas**, an Expert Committee was constituted on the direction of Director of Education, to ascertain the identity of candidate namely Ms. Anita having Roll No. 112005500004, category UR-PH (DOB: 05/02/1982) and the expert committee in the minutes of the meeting held on 26/09/2023 in the office of DDE, DRC E-III issued vide No.DE.3(42)/DRC/E-III/TGT(SANSKRIT)/FEMALE/2022/1470-71 dated 16/11/2023 opined that the candidature of Ms. Anita cannot be considered as she has not clarified how there is a difference in her age mentioned in the disability certificate and educational documents and also failed to produce the original copy of medical disability certificate dated 03/09/1997 and photocopy of which seems tampered with original copy.

**Whereas**, final opportunity dated 05/10/2023, on the advice of Expert Committee was also provided to Ms. Anita to explain the reasons of difference in her name and age, but no reply/representation was received from the candidate.

In view of the above facts and circumstances, the appointment of Ms. ANITA (DOB: 05/02/1982), having Roll No. 112005500004 to the post of TGT Sanskrit (Female), under post code- 55/21 in Level 7 Pay Matrix (Pre-revised Pay Band- 9300-34800 with Grade Pay of Rs. 4600/-) plus usual allowances as admissible under the deemed fit rules, is withdrawn. Now, her candidature stands cancelled, accordingly. Candidate's E-dossier file is being sent to DSSSB for further necessary action at their end.
